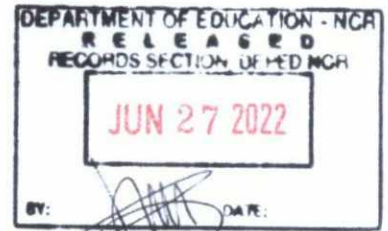

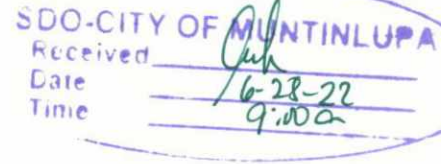

Pursuant to the Department's **Gender-Responsive Basic Education Policy under DepEd Order No. 32, s. 2017**, this Office seeks to promote gender equality, gender equity, gender sensitivity, non-discrimination and human rights in the provision of basic education.

In connection thereto, this Office reminds the field to respect the gender expression of students. **Gender expression** refers to the way in which a person acts to communicate gender within a given culture, for example, in terms of clothing, communication patterns and interests.

In line with the foregoing, School Heads/School Administrators and all school personnel are hereby advised to allow students to attend school-initiated activities, **such as End-of-School Year (EOSY) rites wearing clothes which are aligned with their gender identity**, without restricting students' gender expression provided that the same is approved by their parents/guardians.
