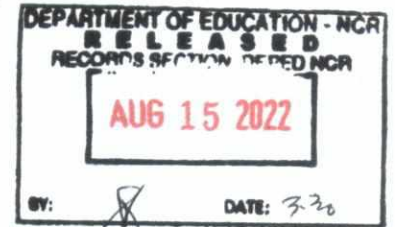

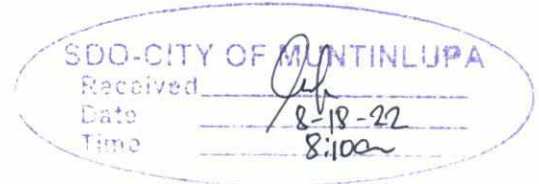

- We are pleased to announce the conduct of the of the Advanced Training Course for LOA with the following details:
 - Date : 22 - 25 September 2022
 - Venue : BP International Hotel, Mt. Makiling, Los Baños, Laguna
 - Participants : Schools Division Superintendent, ASDS, SGOD Chief, CID Chief, EPS and PSDS, Principals
 - Host : Las Piñas City Associate Council
- This training aims to equip our DepEd Officials with scouting skills and to have a deeper understanding of the programs and trainings that we conduct with our students and teachers as scouts and scouts leaders who are the ultimate beneficiaries of this organization. The ATC-LOA is actually conducted for 6 days but considering that this course is specially designed for SDS and other DepEd Officials the course will be in two phases (Modular good for two (2) days and Face to face September 22-25)
- A training fee of Php 17,000.00 non-refundable but transferrable shall be charged each participant for meals, accommodation, kit, program and training materials, souvenir item and honoraria for Course Staff and other administrative requirements chargeable to SEF, MOOE and other funds available subject to usual accounting and auditing procedures.
- Registration fees must be remitted directly to the host Council via bank transfer through their bank account, BSP LAS PIÑAS CITY ASSOCIATE COUNCIL, LandBank Savings Account No. 1551-1502-71 on or before 14 September 2022. The Photocopy or scanned copy of the bank deposit slip must be submitted to the host Council on the same date via email at sktfn@ncrpsdpeped.gov.ph copy furnished the Regional Office via email at rlb@nsdpsdpsd@yahoo.com or thru NCR group chat.
- Each Council is hereby directed to submit list of qualified participants (with the duly accomplished application form) to the Regional Office on or before 02 September 2022. (Please see attached application form)
- All participants are expected to be at the venue on 22 September 2022 at 7:00AM. Meals will be served from 23 September 2022 (Breakfast) up to 25 September 2022 (PM Snacks).
- Participants are required to bring the following:
 - At least two (2) sets of Type "A" uniform
 - Male: Long pants, polo, belt & buckle, black shoes with shoe lace, black socks;
 - Female: Long pants (with flap), blouse, belt & buckle, black shoes with shoe lace, black socks;
 - Filipiniana attire for Socialization
 - Vitamins, maintenance medicines if any, masks, alcohol, sanitizers and other personal needs
 - Laptop
 - Dome Tent (Single)
 - Vaccination card
- All Course Staff and participants should be physically fit, atleast fully vaccinated and must adhere to the policies and protocols of the IATF.
