

I am pleased to endorse to you the *Certificate Course on Family Life Education (FLE)* that the University of Asia and the Pacific (UA&P) will offer in school year 2022-2023.

The full title of the course is

### • IT ALL BEGINS AT HOME: A Certificate Course for Providers and Advocates of FAMILY LIFE EDUCATION

The course consists of 12 modules (six foundational and six professional-technical) delivered over **20 Saturdays** and held **fully online**. Each meeting day features blended learning (combining synchronous and asynchronous sessions lasting a total of six hours).

Synchronous sessions refer to plenary class meetings (the whole class meets online with the module facilitator or resource person). Asynchronous sessions can involve any of the following: individual reading, study, writing, viewing of film, or listening to podcasts; small-group discussions; individual or group consultation; and individual or group mentoring.

UA&P will offer the course twice every school year. The next run is scheduled in January or February 2023 (exact dates to be announced). Admission is open to DepEd NCR teachers and guidance counselors.

Those who are admitted to the course can receive two certificates: (1) a *Certificate of Participation*, to be given to participants who have attended at least nine modules; and (2) a *Certificate of Completion*, to be awarded to participants who, in addition to having attended at least nine modules, submit the plan for a Family Life Education program for a specific target client sector or group.

A soft copy of the course brochure is attached for your information and reference.

To make the course affordable to school teachers, administrators, and guidance counselors, UA&P is tapping the financial support of sponsors. For participants from DepEd NCR, the course fee will be P8,000 per person (equivalent to P400 per meeting day, since there are 20 class meeting days).

I leave it up to your respective Divisions to decide if the participants from your Division will be asked to shoulder part of the course fee to foster in them a sense of ownership and commitment to attend and complete the course, even if UA&P is certain that they will gain real professional and personal benefits from their participation.

DepEd NCR, the course fee will be P8,000 per person (equivalent to P400 per meeting day, since there are 20 class meeting days).

We leave it up to your office to decide if the DepEd NCR participants will be asked to shoulder part of the course fee to foster in them a sense of ownership and commitment to attend and complete the course, even if we are certain that they will gain real professional and personal benefits from their participation.

# "Families do better when they know better."

### WHAT IS FAMILY LIFE EDUCATION?

The domains of professional work and activities related to "family practice" can be grouped into three: marriage and family therapy, family case management, and family life education.

All three fields have the same primary mission: to promote and support the healthy functioning of families and their members. Nonetheless, they can be distinguished as follows:

The focus of marriage and family therapy is on repairing and remedying family dysfunction. It seeks to help family members refocus and rebuild their relationships.

The concern of family case management is to enable families to deal with the legal and policy systems that have an impact on their existence and to gain access to resources necessary for their survival and thriving. Family case managers can, for example, help at-risk youth deal with abuse, drug addiction, or vagrancy and find stable home environments.

By contrast, family life education takes a preventive, educational, and collaborative approach to the promotion of healthy family functioning. The National Council on Family Relations, a US-based organization, defines family life education (FLE) as "any organized effort to provide family members with information, skills, experiences, or resources intended to strengthen, improve or enrich their family experience." Thus, FLE is multidisciplinary in its strategies and methods within a family systems perspective and can be designed for and offered in a wide range of settings.

# <u>THE NEED FOR</u> FAMILY LIFE EDUCATION

A country or society is only as strong as the families that make it up. The Philippines is not an exception in that regard. Today, Filipino families face complex problems that need to be addressed in a systemic way, calling for the involvement of many key sectors, institutions, and individuals from various disciplines and professions.



What is clear is that there is a nationwide need to protect, strengthen, and sustain the well-being of Filipino families. In meeting this national priority, both marriage and family therapy and family case management have important and urgent roles to play. But what is crucial is the creation of a pool of family life educators equipped with the necessary knowledge, skills, and values and capable of crafting and carrying out need-based and well-thought-out programs that promote healthy family functioning.

## THE UA&P CERTIFICATE COURSE ON FAMILY LIFE EDUCATION

In response to this nationwide need, the School of Education (SED) of the University of Asia and the Pacific (UA&P) has designed and now offers a certificate course on family life education.

The course draws on various sources for its content and design: the international and local literature on family life education, the "content areas" identified by the National Council on Family Relations and family life education experts, and notes of experience of local groups and organizations involved in helping families meet their various needs.

The study groups that contributed to the conception of the course identified the following roles, tasks, and work situations that family life education practitioners are expected to take on in the Philippine setting:

<u>Practice:</u> Teaching or providing training in various content areas and themes (including stages of human development; family finances and resource management; entrepreneurship and livelihood; positive disciplinc and communication; time management; marital relations; and education in human love and sexuality); coaching and family counseling

<u>Administration</u>: Establishing networks and partnerships; seeking or creating opportunities for immersion in target client sectors or groups; and facilitating interaction within and among diverse target client sectors or groups.

<u>Promotion:</u> Serving as resource persons for legislation, public policymaking, and advocacies; establishing active presence in media (especially social media).

Given these expected roles, tasks, and work situations, the study groups specified the following set of knowledge, skills and abilities, and values that family life education professionals and practitioners in the Philippine setting should be equipped with:

<u>Knowledge:</u> Developmental psychology (stages of human development); laws related to family; teachings on family (both its philosophical and religious dimensions); natural law; human values; ethical principles; Filipino culture (including local and regional characteristics); current issues and trends; and the "content areas" identified by the National Council for Family Relations.

<u>Skills and Abilities:</u> Communication skills (especially in the vernacular); creativity; adaptability to a given audience and situation; empathy (especially empathic listening); analytical and research skills; ability to craft, deliver (moderate and facilitate), and assess training programs and modules; technological literacy; negotiation and persuasion skills; use of appropriate tools to discern family situations; ability to write cases and use the case method; and community leadership.

<u>Values</u>: Love for God; love for family; concern for the dignity and moral integrity of the person; civic spirit and spirit of service and commitment; pioneering spirit; sense of calling; reflectiveness; respect and nonjudgmental attitude toward others; respect for pluralism and religious freedom; openness, sensitivity, and inclusiveness; and care and concern for the environment (both moral and ecological).



# <u>COURSE</u> CONTENT AND CURRICULUM



# <u>ADMISSIONS, COURSE</u> <u>REQUIREMENTS, AND FACULTY</u>

The certificate course consists of 12 modules (six foundational and six professionaltechnical), delivered over 20 Saturdays and held fully online. Each meeting day features synchronous and asynchronous sessions lasting a total of six hours. These are the 12 modules in the certificate course.

### FOUNDATIONAL

- The Human Person, the Family, and Society
  Human Growth, Development and Mental Health
  Human Sexuality, Marital Relationships, and Spousal Communication
  Philippine Culture and Social Institutions
  Values and Ethics in Family Life Education
  Family Law and Public Policy
  - Interpersonal Relationships, Family Dynamics, and "People Skills" Development
    - Parent Education, Family Counseling, and Mentoring
      - Family Finances, and Resource Management
      - **Research and Field Methods and Practices**
  - Design, Delivery, and Assessment of Family Life Education Programs
    - Current Issues and Trends Concerning the Family

To be admitted to the course, a prospective participant must:

1) have at least a high school degree,

2) present a letter of recommendation from the head of his or her organization or from a reputable person who can vouch for his or her character, and

3) agree to being interviewed by a UA&P representative.

Participants who have attended at least nine modules will receive a certificate of participation. A certificate of completion will be given to participants who, in addition to attending at least nine modules, submit the plan for a family life education program for a specific target client sector or group.

The module facilitators include senior faculty members of UA&P and other resource persons who are experts on the topics assigned to them.
