Respectfully informing your Honorable Office that the Bureau of Corrections will be implementing a Memorandum on the restriction of wearing clothing **with similar color as that of the prescribed PDL uniform** especially during night time at the premises of NBP Reservation particularly-

Maximum Security	<b>Tangerine</b>
Medium Security	<b>Blue</b>
Minimum Security	<b>Brown</b>
PDL WORKERS	<b>Yellow (golden)</b>

NBP residents, individuals, authorized visitors and persons authorized to enter NBP Reservation wearing **printed** clothes similar to the color of the prescribed PDL uniform shall be allowed **except** if it will still give confusion to the gate officer-on-duty/BuCor personnel.

This Memorandum is a part of the enhancement of security measures *to easily identify PDL from personnel, visitor and civilian, to foster easy visual monitoring of PDL during visitation, events or any activities and to easily identify PDL in case of escape.*
