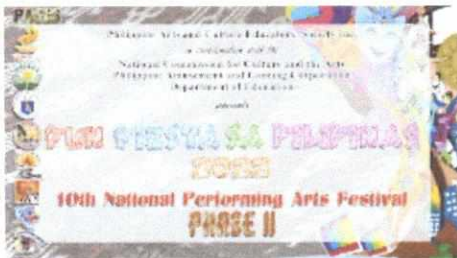



Virtual Competition – Phase Two

### GENERAL GUIDELINES

1. The festival cum competition is open to all recognized school-based performing arts groups in the Philippines. PACES individual members are encouraged to join the competition. **Trainer/Coach and other artistic/creative staff/s of the participating groups must be a PACES Lifetime Member and /or encouraged to join the society.**
2. All expenses in joining the festival cum competition shall be shouldered by the participating groups.
3. A group/dancer/performer may appear more than once in the events of the festival cum competition.
4. A time limit will be enforced and corresponding one point from each judge's total score shall be deducted in the event the time limit is exceeded. The time of performance starts with the first note of the music or the first movement, whichever comes first.

5. All events have an elementary and secondary category.
  6. The Executive Organizing Committee reserves the right to amend these guidelines or refuse any entry on any ground with proper advice to the party/s concerned.
  7. Decision of the Board of Judges is final and irrevocable.
  8. Only the contestants, teacher-trainer/coaches, school administrator/s and judges will be able to view and watch the virtual competition through Google Meet/Zoom (to be hosted by Department of Education and the University of Perpetual Help System Dalta Las Pinas Campus) while the audience can watch through our Facebook live streaming.
  9. A solidarity registration of Five hundred Pesos will be charged to each participating group in every event they will be joining in which includes the freight of the hard copies of the certificates.
  10. All participating performers [**STudent ARTists**] must be officially enrolled in the school they are representing of which is a letter duly certified by the School Head/Administrator shall be issued.
  11. In the event that there will be three or more entries in the same festival event and category level in a certain SDO, the organizing committee will set a date for an elimination to tone down to at least two [2] entries for the said event and category.
  12. In the event that there will a single entry in any specific festival entry and category, said event entry will be considered/rewarded as a Special Outstanding Entry and not as a Champion for the said event and category.
  13. All National Finalists [Student-Participant, Teacher-Trainer/Coach and the School Represented] will be given a Certificate of Recognition/Commendation. Medals, Certificate of Ranking and a trophy for

the Winning Top Three position [Champion, First Runner Up and Second Runner Up].

3. Maximum allotted time for presentation is ten [10] minutes including ingress and egress. Final recorded video of the presentation will be sent to a designated email account on a specific date of submission.
4. Final recorded video of the presentation must be shot on a one camera focus [no editing allowed] with at least two meters away from the service microphone and to be sent to a designated email account on a specific date of submission.





5. Teacher-trainer/coach must ensure the safety of their respective performers during the conduct of the rehearsals and the shooting of the final performances for submission.

6. Deadline of submission of registration/entry form will be November 30, 2022. Virtual Verification and submission of Masterpiece will be on December 10, 2022. Final Competition will be on December 16-18, 2022.

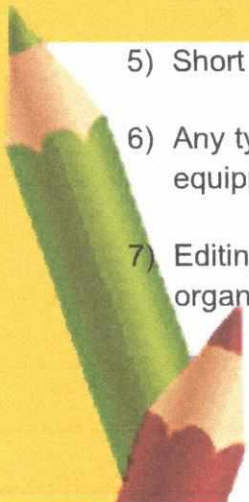
### Competition Rules

- 1) Media Arts Competition is open to all secondary students who are interested in filmmaking and wish to participate.
- 2) All entrants (director, scriptwriter, crew, videographer, editor, and others) must be currently enrolled students who are at least 15 years old and must have his/her parent/guardian sign the form of consent to join said competition.
- 3) All pre-production, production and post-production equipment/s must provided by the participating group.
- 4) All entrants must register on or before **November 30, 2022**. The registration will indicate the names of the entrants as well as their respective roles. They will identify a team name. A duly accomplished registration form must be sent via email to [kultratsining@yahoo.com.ph](mailto:kultratsining@yahoo.com.ph) and/or [philippineartsandcultureeduc@gmail.com](mailto:philippineartsandcultureeduc@gmail.com)

- 5) By signing the Registration Form, the entrants agree to abide by the rules of the competition and the film guidelines and by the decision of the panel of judges.
- 6) PACES-BFTG reserves the right to disqualify any team who fails to comply with the competition rules and film guidelines.
- 7) PACES-BFTG may amend the rules of the competition at any time with proper information-dissemination to all entrants.
- 8) The final copy of the film entry must be submitted no later than **8 o'clock in the morning, November 30, 2022**

### Short Film Guidelines

- 1) All films received on the abovementioned deadline will be part of the competition. Teams who fail to submit their films on the said deadline will be disqualified to join the competition but their films will still be included in the public screening.
- 2) All creative endeavors including but not limited to: scriptwriting, directing, shooting, editing, and musical scoring should be done by the team members. If creative endeavors of the film are done by somebody not part of the registered team member, the film is disqualified to join the competition. The team coach has no hand over the production and post production of the team. No stock file/s are allowed to use in the submitted entry.
- 3) All footage must be shot at any part/places of the participant's locality. Existing footage including but not limited to Fun Fiesta sa Pilipinas 2020, 8<sup>th</sup> National Performing Arts Festival videos may be used as a prop or a set piece in a scene.
- 4) The film must at least be three minutes long but not longer than five minutes in duration, including opening and closing credits.
- 5) Short films should be in Filipino and/or English.
- 6) Any type of video camera or DSLR cameras capable of filming and other production equipment may be used. Use of drone is not allowed.
- 7) Editing software must be done in any software provided it will run in any laptop of the organizing committee..



- 8) The film must be submitted in MP4 format in a USB/FLASH DRIVE without any files attached thereto and must play using standard film/video programs such as Windows Media Player and VLC Player.
- 9) The face of the USB/flash drive should bear the title of the film and the name of the team.
- 10) Usage of pre-recorded music is allowed but these should be acknowledged in the credits of the film. It is however encouraged that, teams come up with original musical scoring.

## DANCE DRAMA

1. Group performance based either on the choreographer's interpretation and/or to the lyrics of the song, *Umuulan Nanaman* by James L. Lastra and *Tingan Nyo-Arkipelago* by Joey Ayala.
2. Student-Pupil/Participants and their Teacher-Trainer/Coach are responsible to do or choose the creative background for the performance
3. Recorded performances must be video on one focus camera with no editing done to its final submitted dance pieces.
4. Dance piece should be original choreography in contemporary form. Obscene choreography, indecent movement and killing of animals are strictly prohibited.





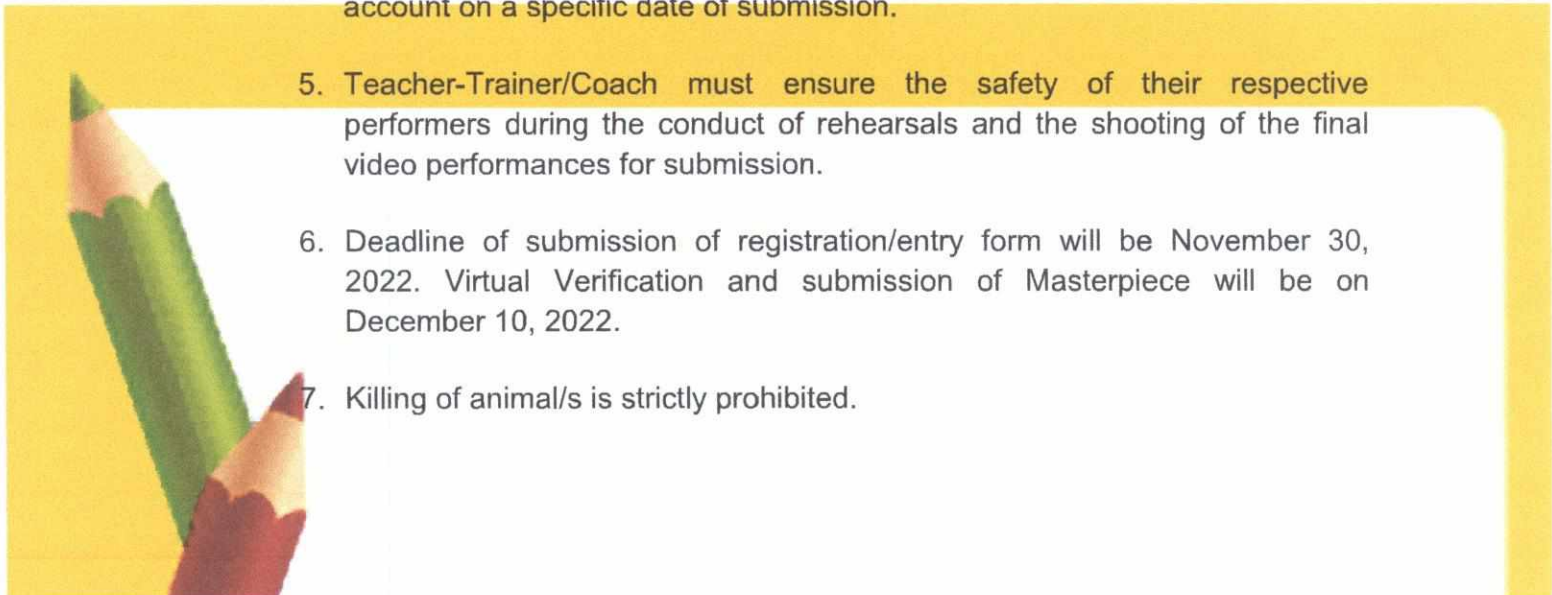
5. Costume must be appropriate to the concept of the dance. Nudity is strictly prohibited.
6. Date of submission of registration entry form will be on 30<sup>th</sup> of November, 2022. Recorded performances must be submitted at a designated email account on or before December 10, 2022.

4. Final recorded video of the presentation will be sent to a designated email account on a specific date of submission.
5. Teacher-Trainer/Coach must ensure the safety of their respective performers during the conduct of rehearsals and the shooting of the final video performances for submission.
6. Deadline of submission of registration/entry form will be November 30, 2022. Virtual Verification and submission of Masterpiece will be on December 10, 2022.
7. Killing of animal/s is strictly prohibited.

- c. No medley of dances is allowed in both choice piece/s. In dances where the literature does not specify or describe the entrance and exit, the trainer/coach may arrange one, however, it must not exceed thirty two [32] measures.
- d. Recorded performances must be shot on one focus camera with no editing done to its final submitted dance pieces. Final recorded video of the presentation will be sent to a designated email account on a specific date of submission.



- e. Teacher-Trainer/Coach must ensure the safety of their respective performers during the conduct of rehearsals and the shooting of the final video performances for submission.
- f. Deadline of submission of registration/entry form will be on November 30, 2022. Recorded performances must be submitted at a designated email account on or before December 10, 2022.

## HIPHOP

- a. The number of participants must be a maximum of ten [10] members.
- b. Duration of the performance must be four to six [4-6] minutes including entrance and exit. Final recorded video of the presentation will be sent to a designated email account on a specific date of submission. Recorded performances must be shoot on one focus camera with no editing done to its final submitted dance pieces.
- c. Teacher-Trainer/Coach must ensure the safety of their respective performers during the conduct of rehearsals and the shooting of the final video performances for submission.
- d. Dangerous stunts are prohibited during the performance. Routine must consist primarily of hiphop technique. May include street dance, free style, funk, pop-n-rock, break dancing. No acrobatic tricks allowed.
- e. Decency of costume/s must be observed accordingly. Removing of pieces of clothes during the performance is allowed provided it is not offensive or out of character.
- f. Only hand props is allowed. Use of pyro-technique materials, sharp objects, water/powderized materials are discouraged.
- g. Music can be remixed or in any original form.



h. Deadline of submission of registration/entry form will be on November 30, 2022. Recorded performances must be submitted at a designated email account on or before December 10, 2022.

2. Participating individual/s are responsible for preparing their own materials. Participating groups shall carry the burden of securing license/permission to perform of their music piece for the competition.
3. In the National Finals, participating groups are required to perform two (2) songs one folk and one OPM of their choice. Each rendition will be treated and judged equally. Submitted final video recording must be shot on a one camera focus and no editing will be allowed with at least two meters away from the service microphone.
4. Maximum allotted time for presentation is ten [10] minutes including ingress and egress. Final recorded video of the presentation will be sent to a designated email account on a specific date of submission.
5. Teacher-Trainer/Coach must ensure the safety of their respective performers during the conduct of rehearsals and the shooting of the final video performances for submission.
6. Deadline of submission of registration/entry form will be on November 30, 2022. Recorded performances must be submitted at a designated email account on or before December 10, 2022.

## ONE ACT PLAY

1. The number of participants must not exceed ten [10] including props men.
2. Original written composition of One Act Play should be anchored on the theme.
3. Music, technical and other special effects can be canned/recorded or actual indigenous musical arrangement and scoring.
4. Each entry is required to submit list of members with their storyline.
5. Participating contingent will present one One Act Play of their choice in the National Final. Presentation for the Final competition must be rooted and grounded on the festival's annual theme.
6. Final recorded video of the presentation will be sent to a designated email account on a specific date of submission.
7. Teacher-Trainer/Coach must ensure the safety of their respective performers during the conduct of rehearsals and the shooting of the final video performances for submission.
8. Deadline of submission of registration/entry form will be November 30, 2022. Recorded performances must be submitted at a designated email account on or before December 10, 2022.
9. Maximum allotted time for presentation is seven [7] minutes including ingress and egress. Final recorded video of the presentation will be sent to a designated email account on a specific date of submission.

### ***[MIXED ART] MOSAIC AND COLLAGE***

1. Solo/Individual work per student/participant.
2. Medium must be derived from available indigenous craft materials [eg. Broken glass, plate's ceramics, paper, wood, etc] to be posted in **18" x 24" plywood for Elementary** and **24" x 36" for Secondary**. Final masterpiece will be form part of the Festival.
3. Teacher-Trainer/Coach must sent pictures of the Artwork process and the final artwork alone; artwork with the student/participant; artwork with student/participant and the teacher-trainer/coach; artwork with student/participant, teacher-trainer/coach and the school administrator together with a three minutes time-lapsed video of the participant while working on his/her student-pupil/participant's masterpiece as Mode of Verification. Video must be in a compact disk and printed pictures.
4. Participant is responsible for preparing their own art materials.
5. Deadline of submission of registration/entry form will be on the 30th day of November, 2022. Virtual submission and verification of masterpiece will be on December 10, 2022
