**3. Nazer Degayo Salcedo (Tenor)**

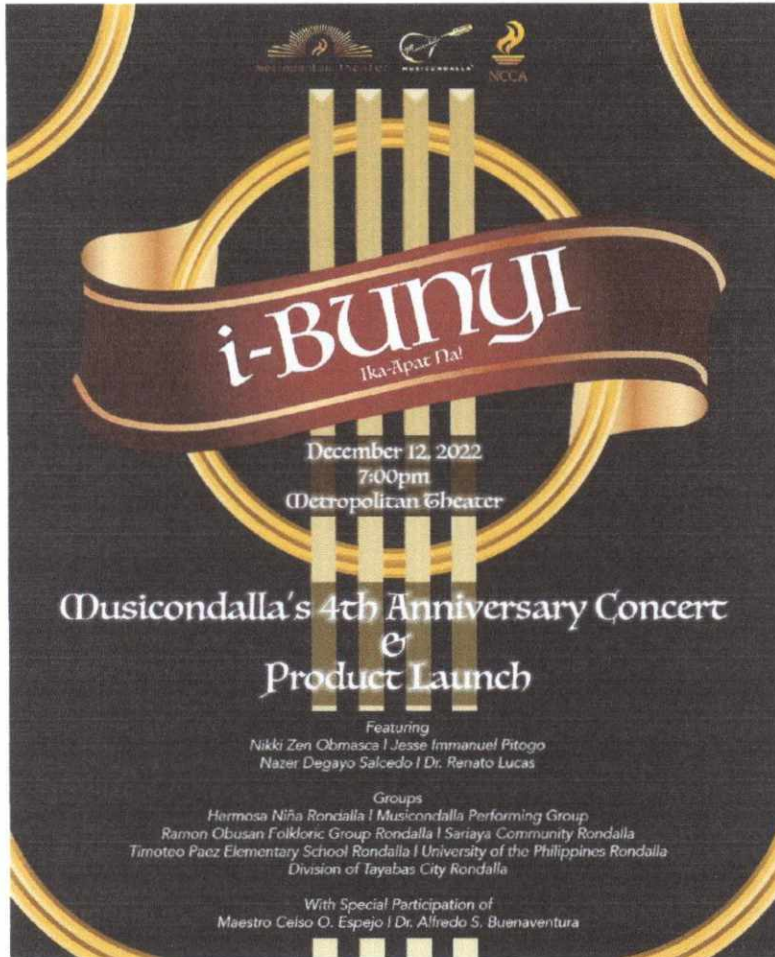
