(Advocacy: Violence Against Women and Children)


- The film Boses, as it has been used in various schools and communities in the Philippines can be utilized as a powerful advocacy tool in the campaign for Children Against Violence.

#OKkaFren? explores topics related to mental health. An insight into the lives of some students who are living with different challenges and offer a glimpse into how they cope.

Marty a product of a broken family spends more time playing online games than studying. His father has his own family abroad while his mother is in illegal online selling. His sister got pregnant early while his brother was imprisoned for drugs. Marty escapes his reality by internet gaming and hanging with the wrong kind of friends.

Paula Mae was once a bright student when her parent's separation greatly affected her studies and her mental/emotional state. Sadly still, she attempted suicide when she was bullied in school and social media when she was labeled as test paper scammer.

Diego is a closet gay who's afraid to admit his gender identity to his parents. Because of social media and the help of some concerned groups he was able to face and tell his true self. **Fiona**, who always causes trouble in class, underwent psychiatric treatment due to having gender dysphoria or gender identity crisis. She initiated the test paper leak in the class that was blamed on Paula Mae due to jealousy and her unhealthy state of mind.

Guia always posted a fake reality and making herself larger than life. She sought her affirmation online and can only feel beautiful and loved by the likes of her viewers. But when she was found out, she was bashed and shamed on social media for her lies.

Macoy, a poor student and became a victim of bullying when he allegedly stole a classmate's wallet. His life and thinking were messed up because of the sin and shame he did not commit.

Due to the increasing issue of mental health issues of the students, **Mr. Calida**, the school officer, formed a group chat called **#OKkaFREN?** -- an online support group for students undergoing confusion, despair, despondency and hopelessness. These students will realize that they are not victims nor just a survivor, but a warrior! Pain is a good teacher and trials make you even stronger. And more importantly, they are not alone.

There is hope even when your sick mind tells you there isn't.
