TO ALL OUR BELOVED TAXPAYERS:

In accordance with Sections 156-161 of R.A. 7160 and Sections 46-48 of the Revenue Code of Muntinlupa, every employee who has been regularly employed on a wage or salary basis for at least thirty (30) consecutive days during any calendar year and who is required by law to file an income tax return shall pay an annual community tax of five (5) pesos and an annual additional tax of one (1) peso for every One Thousand Pesos of income not later than the last day of February of each year.
