DIVISION TIMELINE FOR SENIOR HIGH SCHOOL (SHS) STRAND OFFERING PERMIT APPLICATION, CY 2024

- To: Assistant Schools Division Superintendent Chief Education Supervisor, Curriculum Implementation Division Elementary and Secondary School Heads/OICs Others Concerned
- 1. As part of the ongoing effort of this Division to ensure the effective and efficient implementation of the Senior High School (SHS) Program, the above-captioned timeline is hereby issued. Please see the attachment.
- 2. It shall ensure compliance of the following with the criteria set under Part VI.A. 1. DepEd Order 51, s. 2015 within the prescribed period to guarantee the timely issuance of DepEd permit:
 - 2.1 Public SHSs with strand offerings covered by the procedural guidelines exemption granted in SY 2016-2017 due to exigencies of the SHS implementation timeline (Part III of DepEd Order 51, s. 2015); and
 - 2.2 Public SHSs seeking to offer additional SHS strands.
- 3. It is reiterated that no additional strand offerings may be implemented without the required DepEd approval.
- 4. For wide dissemination and strict compliance.
