- The allocation for SDO Muntinlupa in the forthcoming FY 2023 NQESH stands at 39 slots.
- Due to the limited availability of slots, this Division will be implementing its contextualized scheme of evaluation in accordance with the basic requirements and prioritization outlined in DepEd Memo No. 13, s. 2024. Following this process, if the number of applicants exceeds the number of available slots, priority will be given to candidates based on their number of years in the service in their current position. Specifically, consideration will be given to Master Teachers, Teacher III positions, and incumbent public-school teachers with managerial and supervisory experience from previous employment in DepEd-recognized private schools of CHED-recognized HEIs after the assessment of the documents the Head Teachers and incumbent OICs of schools.
- Immediate, wide dissemination of, and strict compliance with this Memorandum are desired.

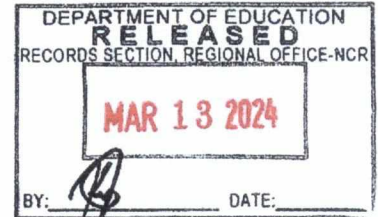
