

Subject : Revocation of Memo Issued on 30 April 2024,
 Prescribing the Wearing of Regular Uniform

The Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) has officially declared the start of the 2024 rainy season on 29 May 2024, Friday. With this development, the Memo issued by the City Human Resources Management Department, signed by the City Mayor, and dated 30 April 2024, allowing the wearing of Type B uniform on workdays, shall be effective only until 28 June 2024, Friday.

Effective 01 July 2024, Monday, all heads and employees shall return to wearing the prescribed uniform during workdays. Wearing Type B uniform shall solely be allowed on Fridays and for meritorious reasons.

The CHRMD shall monitor full compliance thereto, and shall impose sanctions, whenever warranted.
