

Dear Ms. Bernardo:

This refers to your letter dated June 6, 2024 relative to the Union's Leadership Training-Seminar rescheduled on August 23-25, 2024 at the Baguio Teachers Camp.

With regard to your request that a corrigendum on Regional Letter No. 078, s. 2024 be issued indicating that the registration fee and transportation expenses be sourced out either from canteen fund, MOOE or SEF fund, please be informed that the authority for the use of the said funds is within the accountability and responsibility of the school heads pursuant to existing guidelines. Thus, this need not be directed by this Office.

The request for the grant of two-day service credits for the Union leaders' attendance to the said Leadership Training can not granted as it does not fall under any of the activities under DepEd Order No. 53,s. 2003. The basic policy as declared in the said DepEd Order is that "the grant of vacation service credit should be given only for work beyond regular functions or beyond regular work hours/days where payment of honorarium or overtime is not possible." However, pursuant to Section 1, Article IV of the 2024 Collective Negotiation Agreement, the travel for August 23, 2024 shall be considered on official time.

We would like to respectfully advise your good office that the ACT NCR Union Leadership Training-Seminar is rescheduled on August 23-25, 2024 at Baguio Teachers Camp.

The said leadership training-seminar is in line with the ladderized education program (LEP) of the Alliance of Concerned Teachers-National Capital Region Union through ACT NCR Union Research and Education Committee in partnership with the sector's education arm/institution Paaralang Teresa Magbanua para sa mga Guro (PTMG). This seminar with the theme "Rectify, Organize, Struggle, and Succeed: Strengthening Collective Leadership through Patriotic, Progressive, and Militant Unionism" will be attended by 500 ACT NCR Union leaders and active members coming from all schools divisions in the National Capital Region. The three-day seminar aims to equip union leaders and active members with advanced union leadership principles and competencies in managing school union chapters, district union councils, and union division chapters with emphasis on organization and membership work, research and education work, campaign and propaganda work, finance work, teachers' welfare and services work, and human rights work.

It must be strictly noted that the participants in the seminar should be duly identified and endorsed by the executive officers of the union division chapters.

> A registration fee of Php 4,200.00 will be charged to each participant to defray expenses for food, accommodation, training kits, certificates, and other related expenses. Transportation cost is estimated at Php 2,000.00.
