3. Furthermore, the results of the assessments must serve as the basis for formulating appropriate intervention programs and deciding whether to continue existing intervention programs.

4. Schools are encouraged to fully support their teachers in conducting the assessments and intervention/remediation for learners. If the assessments and interventions are conducted on weekends or holidays, teachers shall be entitled to service credits in accordance with DepEd Order No. 53, s. 2003, which outlines the Updated Guidelines on the Grant of Vacation Service Credits to Teachers. Additionally, non-teaching personnel involved in these activities shall be provided with Compensatory Time-Off (CTO) in line with the Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004, on Non-Monetary Remuneration for Overtime Service Rendered.

5. Expenses related to the conduct of the above-mentioned activities and the intervention program, including but not limited to the provision of intervention materials, shall be charged against local funds. These expenditures are subject to the usual budgeting, accounting, and auditing rules and regulations.
