In compliance with Mayor Ruffy's Executive Order 18 s. 2024, the City Health Office and SDO Muntinlupa are integral parts of the Project AGAP Protocol and are duty bound to address the medical and educational needs of children with disability and aggressively promote early detection and intervention.

Furthermore, in observance of the signed MOA between the City Government of Muntinlupa and The Bellevue Manila (TBM), we are requesting for the TBM Management for the provision of venue for the Project AGAP Partnership as stipulated on the said agreement.

With this, we humbly request the City Health Office for the provision of 1 Licensed Psychologist that will help assess the children with disability on the selected remaining wednesdays and fridays of 2024.

We would also like to ask our SDO Muntinlupa to disseminate information, refer and coordinate with Ms. Susana Canete, their students with disability who are in need of Psychoeducational Assessments. May we also request to pull-out students during class hours and be accompanied by their parents to avail of this free service.

Muntinlupa PDAO shall provide the Assessment Tools, pool and schedule the SPED Students for this activity. Ms. Susana Canete shall coordinate the schedule and roster of patients / students that need to be assessed.

We have tried different approaches and avenues to solve this such as Direct Contracting and KMAC Financial Assistance but it has not been as successful or efficient as we have projected so this is our "Plan B" to still be able to reach the goal of 500 CWDs assessed.
