

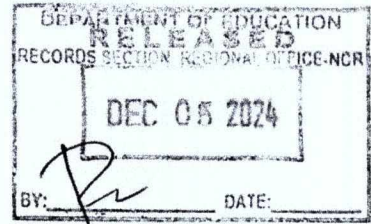

In line with DepEd Order No. 026, s. 2022 "Implementing Guidelines on the Establishment of School Governance Council (SGC)," the Bureau of Human Resource and Organizational Development – School Effectiveness Division (BHROD-SED) developed a tool intended to support its implementation and assess SGC functionality based on the provided indicators. Baseline data were gathered from September 2022 to March 2023 to understand the context of the SGCs then and identify priority areas needing support and assistance from the different governance levels.

Following this, the BHROD-SED rolled out the SGC Functionality Assessment Tool for SY 2023-2024 to assess the progress of the SGC and conducted the endline data collection from 26 September 2023 to 21 June 2024.

The BHROD-SED, in partnership with the Asian Development Bank (ADB), is currently in the process of consolidating, verifying, and analyzing the endline data.
