RESOLUTION TO AWARD

WHEREAS, SDO-Muntinlupa procured the **BOARD AND LODGING FOR THE CONDUCT OF THE 3-DAY ENHANCEMENT OF THE DIVISION AND SCHOOLS CONTINGENCY PLANS FOR THE DIFFERENCE HAZARDS IN THE NEW NORMAL** with an Approved Budget for Contract (ABC) **THREE HUNDRED FIFTY-FOUR THOUSAND PESOS (PHP354,000.00)**;

WHEREAS, the BAC resolved that the procurement mode appropriate for the ABC threshold is Negotiated Procurement-Lease of Property or Venue, and recommended the same to the HOPE;

WHEREAS, on January 30, 2024, the BAC-Secretariat prepared the Request for Quotation (RFQ) and was able to send to three known providers;

WHEREAS, on February 5, 2024, only one (1) quotation was received, however it was submitted beyond the deadline. The BAC directed the BAC Secretariat to coordinate with the end-user to reschedule the project's implementation date in light of the BAC procurement timeline;

WHEREAS, on February 12, 2024, the BAC-Secretariat prepared the Request for Quotation (RFQ) of the aforementioned project with adjusted date and was able to send to three known providers;

WHEREAS, on February 16, 2023, one (1) quotation was received, and the lowest bidder was found to be compliant with the specifications of the project
