RESOLUTION TO AWARD

WHEREAS, SDO-Muntinlupa procured *Meals for the Training Workshop on Literacy Intervention Program* (Key Stage 1 and 2) Emergent, Beginning and Developing, and Transitioning Literacy for Reading Teachers (Kindergarten – Grade 6) with an Approved Budget for the Contract (ABC) of Ninety Six Thousand (P 96,000.00);

WHEREAS, the BAC resolved that the procurement mode appropriate for the ABC threshold is Negotiated Procurement - Small Value Procurement (SVP), and recommended the same to the HOPE;

WHEREAS, on September 04, 2024, the BAC-Secretariat posted the project in the PhilGEPS;

WHEREAS, on September 09, 2024, three (3) quotations were received, and during the opening, the lowest calculated bidder (SD Publications, Inc.) was found to be compliant with the specifications of the project;

WHEREAS, on September 11, 2024, during the scheduled TWG for Goods Post Qualification, SD Publications, Inc. did not present their organizational chart, previous contract/s and they have no actual office;

WHEREAS, on September 19, 2024, a signed letter of post disqualification was sent to SD Publications, Inc. thru email. If they wish to request for a reconsideration, they may do so within three (3) calendar days from receipt of the letter;

WHEREAS, on September 23, 2024, the TWG for Goods did a Post Qualification for the second lowest calculated bidder, Aleja's Cuisina Catering Services, and was found to be compliant with the specifications of the project;

WHEREFORE, all premises considered, the Bids and Awards Committee resolves, as it is hereby Resolved, to recommend the award of contract to the second lowest calculated bidder, Aleja's Cuisina Catering Services in the amount *Ninety One Thousand Two Hundred Pesos (P 91,200.00)* through Negotiated Procurement – Small Value Procurement.
