## **RESOLUTION TO AWARD**

WHEREAS, SDO-Muntinlupa procured *Procurement of Weighing Scale* (with Height and Weight) and Family Germicidal Bar Soap with an Approved Budget for the Contract (ABC) of One Hundred Twenty Thousand Four Hundred Six Pesos (P 120,406.00);

WHEREAS, the BAC resolved that the procurement mode appropriate for the ABC threshold is Negotiated Procurement - Small Value Procurement (SVP), and recommended the same to the HOPE;

WHEREAS, on September 17, 2024, the BAC-Secretariat posted the project on PhilGEPS;

WHEREAS, on September 20, 2024, three (3) quotations were received (two (2) sealed envelopes and one (1) thru email), and during the opening, the lowest calculated quotation (Ayamed Drug Distributor, Inc.) was found to be compliant with the specifications of the project;

WHEREAS, on September 30, 2024, during the scheduled TWG for Goods Post Qualification, Ayamed Drug Distributor, Inc. was not able to present their list of latest procurement, organizational chart, and other requested documents are in their satellite office in Cainta, Rizal;

WHEREAS, on September 30, 2024, a signed letter of post disqualification was sent to Ayamed Drug Distributor, Inc. thru email indicating that if they wish to request for a reconsideration, they may do so within three (3) calendar days from receipt of the letter;

**WHEREAS**, on October 08, 2024, the TWG for Goods conducted a Post Qualification for the second lowest calculated bidder, Gegav General Merchandise, and was found to be compliant with the specifications of the project;

WHEREFORE, all premises considered, the Bids and Awards Committee resolves, as it is hereby resolved, to recommend the award of contract to the second lowest calculated bidder, Gegav







General Merchandise in the amount One Hundred Fifteen Thousand One Hundred Forty Four Pesos (P 115,144.00) through Negotiated Procurement – Small Value Procurement.
