CONTRACT AGREEMENT
No. 2024-04-03

THIS AGREEMENT made the 30th day of April 2024 between **SDO MUNTINLUPA CITY, Student Center for Life Skills (SCLS), Centennial Avenue, Laguerta, Tunasan, Muntinlupa City, Philippines**, hereinafter called "the Entity" of the one part and **HOSPITALITY INTERNATIONAL INC. (PARQUE ESPAÑA RESIDENCE HOTEL), East Asia Drive Filinvest Corporate City, Philippines**, hereinafter called "the Supplier" of the other part;

WHEREAS, the Entity invited quotation for certain goods and ancillary services, particularly **THE MEALS AND VENUE FOR THE CONDUCT OF THE 2-DAY DIVISION INTER AGENCY CONFERENCE ON DEPED ORDER NO. 18 S. 2015 ON HANDLING ILLICIT DRUGS/SUBSTANCE RELATED INCIDENTS FOR THE PROTECTION AND SAFETY OF OUR LEARNERS IN PUBLIC SCHOOLS** and has accepted a Bid by the Supplier for the Lease of Venue in the sum of **ONE HUNDRED SIXTY THOUSAND PESOS (PHP160,000.00)** hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Request For Quotation (RFQ);
 - ii. Winning bidder's quote, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

RFQ, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **ONE HUNDRED FORTY-FOUR THOUSAND PESOS (PHP160,000.00)** or such other sums as may be ascertained, **HOSPITALITY INTERNATIONAL INC. (PARQUE ESPAÑA RESIDENCE HOTEL)**, agrees to **THE MEALS AND VENUE FOR THE CONDUCT OF THE 2-DAY DIVISION INTER AGENCY CONFERENCE ON DEPED ORDER NO. 18 S. 2015 ON HANDLING ILLICIT DRUGS/SUBSTANCE RELATED INCIDENTS FOR THE PROTECTION AND SAFETY OF OUR LEARNERS IN PUBLIC SCHOOLS** in accordance with his/her/its Bid.
4. The **SDO-MUNTINLUPA CITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
