RFQ, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation.

iii. Notice of Award of Contract; and the Bidder's conforme thereto; and

iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **One Hundred Twenty Thousand Pesos (P 120,000.00)** or such other sums as may be ascertained, **PARQUE ESPAÑA RESIDENCE HOTEL**, agrees to the **Provision of Meals and Venue for the Conduct of 2025 SDO Budget Formulation Workshop: Crafting of Project Profiles, PPMP, APP and APP - CSE (Live - Out)** in accordance with his/her/its Bid.

4. The **SDO-MUNTINLUPA CITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
