SUBJECT : LOAN ENTITLEMENT TAGGING FOR OUTGOING ELECTIVE OFFICIALS, CO-TERMINOUS, CASUALS AND PERMANENT OFFICIALS WHOSE TERM WILL END ON

JUNE 30, 2025

In preparation for the upcoming mid-term elections and in consideration of the expiration of the term of office for outgoing elective, co-terminous, casual, and non-permanent officials on June 30, 2025, the GSIS has implemented a special tagging mechanism in its database. This measure will temporarily deactivate the loan entitlement of the affected members.

This special tagging also applies to members with Periods with Paid Premiums (PPP) of less than fifteen (15) years. Consequently, officials and employees with these employment status will be unable to avail of loans until after the elections.

To facilitate the prompt reactivation of loan entitlements and the updating of member records for re-elected or re-appointed officials, government agencies are requested to immediately advise GSIS and submit the necessary supporting documents for the concerned employees or officials.

Please be guided accordingly.
