Following the letter request issued by the Department of Disaster Resilience and Management (DDRM), signed by Erwin O. Alfonso, PhD., and dated 17 January 2025, all officers and employees of the City Government are enjoined to download the iRespond Muntinlupa Mobile Application, for the reasons enumerated below, to wit:

- (1) This application affords the individual to report quickly any emergency or incident in need of immediate attention or response;
- This affords the whole city the opportunity to be a vast and comprehensive network, (2)wherein citizens can perform their civic duty to be involved in disaster mitigation and quick response, and officers and employees of the City Government should take the lead therein:
- The app has features on weather updates and advisories, safety tips, early warning, (3) facilities, evacuation alerts, hazards and other related information;
- (4) The application is easy to download via Google Play Store or Apple IOS. Once downloaded, the individual will be required to register using one (1) valid identification card. The registration is guaranteed compliant with the Data Privacy Act.


