EARLY REGISTRATION FOR SCHOOL YEAR 2025-2026

To: OIC-Assistant Schools Division Superintendent Chief Education Supervisor, Curriculum Implementation Division OIC-Chief Education Supervisor, School Governance & Operations Division Public and Private Elementary and Secondary School Heads/OICs All Others Concerned

1. Attached is DepEd Regional Memorandum No. 044, s. 2025, dated January 7, 2025, on the above-captioned subject, the contents of which are self-explanatory, for the information and compliance of all concerned.

2. It was announced in the abovementioned provision, that the Early Registration for the SY 2025–2026 will begin on January 25, 2025.

3. The term "early registration" describes the pre-registration of incoming Kindergarten, Grades 1, 7, and 11 learners that takes place before start of classes. According to DepEd rules, learners in other grade levels are already considered "pre-registered."

4. All public elementary and secondary schools in this Division are required to conduct Early Registration for incoming Kindergarten, Grades 1, 7, and 11 learners which shall start from the last Saturday of January to the last Friday of February of this year.

5. In order to guarantee accurate reporting, both public and private schools are required to use the school head's LIS account to encode and update learner data every day in the Early Registration facility.

6. The kindergarten cutoff age as specified in DepEd Order No. 20, s. 2018 (Amendment to DepEd Order No. 47, s. 2016), is to be strictly enforced and implemented by public and private school authorities. The requirement that kindergarten learners be five (5) years old by the following:

Date of Opening of Classes	Cut-off Date
June	August 31
July	September 30
August	October 31

All public and private elementary and secondary schools must engage in several initiatives to attract potential registrants and be ready for early registration, including other stakeholders in the process and make sure that all new entrants are registered for the School Year 2025–2026 for Kindergarten, Grades 1, 7, and 11.





EARLY REGISTRATION FOR SCHOOL-YEAR 2025-2026

- 1. In reference to DepEd Order No. 009, s. 2024, titled "Implementing Guidelines on the School Calendar and Activities for School Year 2024-2025," early registration for incoming Kindergarten, Grades 1, 7, and 11 for School Year 2025-2026 will begin on January 25, 2025.
- 2. Early registration refers to the pre-registration of incoming Kindergarten, Grades 1, 7 and 11 learners, conducted prior to the start of classes. Meanwhile, learners in other grade levels are already deemed "pre-registered" in accordance with DepEd's policy.
- 3. All public elementary and secondary schools in the region are required to conduct early registration for incoming kindergarten, Grades 1, 7 and 11 learners starting from the last Saturday of January to the last Friday of February each year.
- 4. To ensure accurate reporting, all public and private schools are directed to encode and update learners' data daily in the Early Registration facility using the school head's or school administrator's account in the LIS.
- 5. Authorities of public and private schools are reminded to strictly enforce and implement the Kindergarten cut-off age as stipulated in D.O. No. 020, s. 2018 (Amendment to DepEd Order No. 47, s. 2016).

- 7. Ensure that all new entrants for Kindergarten, Grades 1, 7, and 11 in public and private elementary and secondary schools in your respective divisions are registered for School Year 2025-2026.

Pursuant with the DepEd Order No. 03, s. 2018, "Basic Education Enrollment Policy", and DO 09, s. 2024 or the "Implementing Guidelines on the School Calendar and Activities for the School Year (SY) 2024-2025", the conduct of the Early Registration for incoming Kindergarten, Grades 1, 7, and 11 learners in public schools for School Year 2025-2026 shall commence on 25 January 2025 and ends on 15 February 2025.

Early registration is conducted to ensure that all new entrants for the abovementioned grade-levels are registered.

All public elementary and secondary schools shall be guided accordingly of the following matters:

- 1. Early registration may be done through face-to-face registration within the schools and/or implement other means of reaching out to learners and collecting early registration forms.
- 2. Public elementary and secondary schools shall use the printed or electric copy of the Basic Education Early Registration Form to ensure that necessary information in registering incoming Kindergarten, Grades 1, 7, and 11 learners are properly captured. A copy of the said Form is attached as Annex 1 to this memorandum and can be downloaded here: https://bit.ly/SY2025_2026EarlyRegForm.



- 3. Daily reporting of the school's early registration data in the Learner Information System (LIS) - Early Registration facility shall be done using the School Head or School Administrator account.
- 4. Authorities of public and private schools are instructed to strictly enforce and implement the kindergarten cut-off age as stipulated in DO 020, s. 2018 (Amendment to DepEd Order no. 47, s. 2016).
- 5. Schools shall also intensify the conduct of child-mapping or house-to-house activities to encourage parents/guardians to register school-aged children and Out-of-School Children and Youth (OSCY) in the communities.
- 6. Schools Division Superintendents and school heads shall facilitate the conduct of advocacy campaigns within their respective jurisdictions to inform the general public and encourage parents/guardians of prospective learners to participate in the Early Registration for SY 2025-2026.
