SUBJECT : 2025 EARTH HOUR CELEBRATION

1. As part of our commitment to help save the planet Earth, the Boy Scouts of the Philippines is pleased to announce our continuous participation to the **2025 Earth Hour Celebration**, in partnership with the World Wildlife Fund (WWF) – Philippines. With the local theme, "**Switch Off and Secure Water for All**", this year's Earth Hour directs our attention to the interconnectedness of water security, nature loss, and climate change.
2. The **Earth Hour Celebration** aims to provide a platform to urgently promote the advocacy of addressing the planet's biggest environmental challenges and call on the world leaders to decide on a new global action plan for nature for the coming decade.
3. In line with this, we encourage all Scouting Units nationwide to participate by switching off the lights for **one hour (60 minutes) on March 22, 2025 from 08:30 P.M. to 09:30 P.M.** This can make a substantial difference in energy consumption and can help reduce the effect of global warming on this planet.
4. Apart from the one-hour switch-off activity, we are encouraged to give an hour to Earth or to spend at least an hour doing something positive for the planet. We encourage all Scouts nationwide to log onto the Hour Bank at the Earth Hour website: <https://www.earthhour.org/take-part/give-an-hour> to measure the total impact of Earth Hour. The target hours of the BSP for the Hour Bank is **one (1) million hours**.
