- 3. Furthermore, the results of the assessments must serve as the basis for evaluating the effectiveness of implemented programs and determining the next steps for sustaining or refining existing initiatives.
- 4. Schools are encouraged to provide full support to teachers in conducting assessments for learners. If assessments are administered on weekends or holidays, teachers shall be entitled to service credits in accordance with **DepEd Order No. 53, s. 2003**, which outlines the **Updated Guidelines on the Grant of Vacation Service Credits to Teachers**.
- 5. Additionally, non-teaching personnel involved in these activities shall be granted Compensatory Time-Off (CTO) in compliance with the Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004, which governs Non-Monetary Remuneration for Overtime Service Rendered.
- 6. Expenses related to the conduct of the assessments shall be charged against local funds. These expenditures are subject to the usual budgeting, accounting, and auditing rules and regulations.
