

- 3. The Regional Performance Management Team shall have the following functions and responsibilities:
  - lead in designing and reviewing the alignment of the Region and Office Performance targets and indicators with the agency's long-term and medium-term plans, organizational outcomes, strategic priorities, and other performance frameworks;
  - b. ensure translation, alignment, and cascading of organizational commitment to Functional Divisions and the 16 SDOs of the region;
  - c. validate the submitted acceptable means of verification (MOVs) during the SDSs and Chiefs of the functional division;
  - d. convene as a group to discuss and address performance-related issues, including matters related to the RPMS policy review, operational guidelines, rules, and protocols within the regional office as well as those unresolved in the SDOs, as outlined in Section XI of DO No. 2 s. 2015 and any other subsequent issuances;
  - e. personnel section identifies potential top performers and provide inputs to the PRAISE Committee for grant of awards and incentives based on the criteria set or guidelines;
  - f. the secretariat sets consultation meetings with all Heads of Offices (SDSs and Functional Division Chiefs) to discuss the targets set in the office performance commitments and rating form;
  - g. the Planning Office and Human Resource Development Division shall perform the tasks stipulated DepEd Order No. 2, s. 20215;
  - h. RPMT recommends approval of the office performance commitment and rating to the Head of Office in the Region;
  - the RPMT adopts its own internal rules, procedures, and strategies in carrying out the above responsibilities, including a schedule of meetings and deliberations and the delegation of authority to representatives in case of the absence of its members; and
  - j. adhere to Equal Opportunity Principle and ensure gender responsive performance management process.

- 4. The regional pool of assessors may be invited as external validators to help in the validation of OPCRF and IPCRF at the regional and division levels. Furthermore, regional and division Performance Management Teams shall ensure strict implementation of the Results-Based Performance Management System and are expected to be ready for regional visitation as to practice. See enclosed list of Regional Pool of Assessors
- 5. All expenses related to any activity to be conducted by the RPMT such as but not limited to travelling expenses, food, venue, supplies, and materials shall be charged to the Regional Office Funds/ HRD Funds (Continuing and Current) subject to the existing budgeting, accounting, and auditing rules and regulations.
