

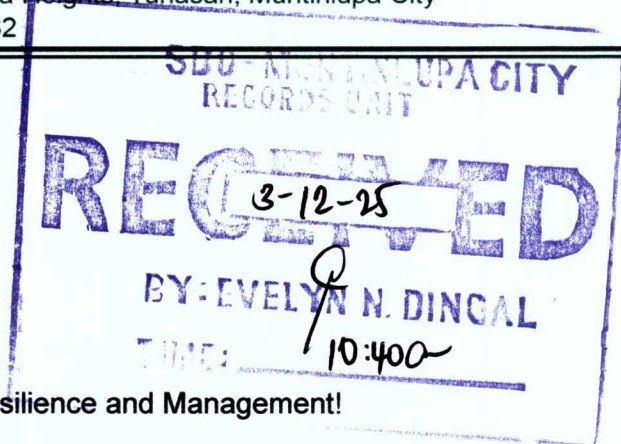

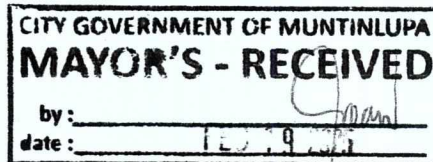

Greetings from Department of Disaster Resilience and Management!

This is to inform you that we will be initiating the dissemination of DPA program thru the **“Mobile Learning Hub”** program that will use of an innovative approach to promoting disaster preparedness among students of Muntinlupa City. The MLH program aims to disseminate disaster preparedness information to 600 participants from selected public and private elementary and high schools. Each school will undergo three (3) sessions with 30 participants, covering three key topics:

Session 1 : Family Preparedness with Virtual Reality: Educating participants on how to prepare their families for disasters.

Session 2.: Early Warning System: Teaching participants about early warning systems and how to respond to disaster alerts.


Session 3 : Search and Rescue: Exposing the students with actual demonstration on the use of common equipment used for Search and Rescue.

The MLH dissemination is scheduled to take place from April to July. Due to the size constraints of the bus, we will be strategically selecting participating schools based on their geographic location ensuring optimal utilization of our resources. This dissemination will increase accessibility and flexibility for the participants, improved engagement enhancing retention and recall of disaster preparedness information.
