- 1. In reference to **DepEd Order No. 10, s. 2025**, the Department of Education National Capital Region, through the Curriculum Management and Learning Division, will conduct the **Summer Remediation Materials Preparation for Grades 4 to 12 Mathematics** on **April 29 to May 3, 2025**, within the NCR.
- 2. The objective of this activity is to organize and prepare the necessary materials that will be utilized during the 20-day Regional Remediation Program, which will commence on May 13, 2025, and conclude on June 6, 2025.
- 3. The preparation of materials for math remediation involves a comprehensive process, beginning with the alignment of all resources to the curriculum standards, ensuring they address essential mathematical concepts for Grades 4 to 12. These materials will undergo thorough reviews for clarity, accuracy, and effectiveness, to ensure they meet the diverse needs of students and educators prior to final distribution. This approach aims to enhance student understanding and proficiency in mathematics, ultimately fostering a positive learning experience.
- 4. At the end of the 5-day activity, participants are expected to produce a comprehensive set of grade-appropriate math remediation materials, including worksheets, online resources, and instructional guides, all tailored to strengthen learners' mastery of key mathematical concepts.
- 5. Division Mathematics Supervisors must ensure that the appropriate participants are designated for the activity, in accordance with the attached allocation of participants per Schools Division Office (SDO).
