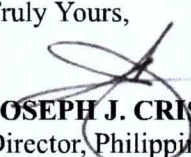

**MEMORANDUM OF AGREEMENT
(MOA)**

KNOW ALL MEN BY THESE PRESENTS:

This Agreement made and entered into this 9th day of February 2013, in the City of Pasay, Philippines by and between:

The **NATIONAL COMMISSION FOR CULTURE AND THE ARTS**, a government agency created by and pursuant to Republic Act No. 7356 dated 3 April 1992, with office address at NCCA Building, 633 General Luna Street, Intramuros 1002 Manila represented by its Chairman **FELIPE M. DE LEON, JR.**, hereinafter referred to as "NCCA".

The **DEPARTMENT OF EDUCATION**, a government agency created by law and pursuant to Republic Act No. 9155 dated 24th July 2000, with office address at DepED Complex, Meralco Avenue, Pasig City, represented by its Secretary, **BR. ARMIN A. LUISTRO FSC**, hereinafter referred to as "DepED".

WITNESSETH

WHEREAS, the State recognizes that culture is a human right to be accorded respect and allowed to flourish, that the Filipino national culture shall be evolved and developed by the people themselves in a climate of freedom and responsibility, and that the Filipino national culture shall be equitable, effectively creating and distributing cultural opportunities to all;

WHEREAS, the NCCA is mandated to ensure the widest dissemination of artistic and cultural products among the greatest number across the country and overseas for their appreciation and well-being;

WHEREAS, the NCCA in this mandate may collaborate with the Department of Education and all other concerned agencies, public and private, and cause to be established and developed an intensified culture and arts education program at all levels of the educational system, public and private, to ensure meaningful culture and arts integration across the school curriculum, and encourage and support continuous training of cultural workers and administrators by qualified trainers;

WHEREAS, the Constitution mandates all educational institutions to inculcate patriotism and nationalism, foster love for humanity, respect for human rights, appreciation of the role of national heroes in the historical development of the country, teach the rights and duties of citizenship, strengthen ethical and spiritual values, develop moral character and personal discipline, and encourage critical and creative thinking;

WHEREAS, it is one of the objectives of the DepED to make schools and learning centers the most important vehicle for the teaching and learning of culture and the arts, and national values and for developing the Filipino learners' love of country and pride in its rich heritage;

NOW THEREFORE, The NCCA and the **DepED** hereto mutually agree to collaboratively conduct cultural education programs and activities such as but not limited to teacher training and development of training modules and instructional materials.

I. Object of the Agreement. -- Both parties agree to create an **NCCA - DepED Cultural Education Program (NDCEP)**.

The parties will establish a strong collaboration and networking activities between themselves in the formulation and implementation of plans and programs for the integration and mainstreaming of Philippine arts and culture in the basic education system.

A. The purposes of the said agreement are as follows:

1. The development and implementation of an enhanced **Special Program for the Arts (SPA)** curriculum with production of instructional and resource materials;
2. The mainstreaming of Indigenous Knowledge Systems, Skills and Practices (IKSSP) through the institutionalization of an appropriate **"School for Living Traditions (SLTs)"** model in the formal education systems;
3. Support the **K to 12 Program** of DepED, [both in the formal and informal systems], particularly the subjects on heritage, culture and arts through teacher training, resource materials and by formulating competencies for arts-related careers;
4. The institutionalization of the training of students and teachers on arts and culture for both in-service and degree programs under the NCCA Philippine Cultural Education Program (PCEP) in line with Article X of Section 38 of RA No. 10066 or the Cultural Heritage Law; and,
5. Cultural enrichment activities for students, teachers, and education administrators in the formal and non-formal systems.

B. Composition. -- The **NCCA-DepED Cultural Education Program Committee (NDCEPC)** shall be composed of seven (7) members, five (5) assigned by or organically with the NCCA and two (2) from DepED. The NCCA Plan/Policy Formulation and Programming Division (PPFPD) or its successors in interest shall be the Secretariat.

II. Obligations of the Parties.—The parties shall undertake the following obligations:

A. The NCCA shall:

1. Identify the components of the Special Program for the Arts Curriculum (SPA) then turn over the same for drafting into curriculum by the DepED;
2. Coordinate with the DepED for the institutionalization of the SLTs and their inclusion into continuing DepED programs, details of which shall form part and annexure of this MOA;
3. Appoint five permanent representatives to the NCCA-DepED Cultural Education Program Committee (NDCEPC);
4. Initiate and facilitate the development and implementation of the NDCEP;



5. Tap culture and arts experts, and masters of living traditions (MLT) to provide the content, information and material resources for the NDCEP;
6. Provide culture and arts experts and MLTs for the actual implementation of the program such as the trainings and instructional materials production;
7. Allocate budget for the NDCEP subject to the regular NCCA grants process; and,
8. Provide Secretariat for the activities of the NDCEP.

B. The DepED shall:

1. Include in the formal and non-formal system culture and the arts, the SLTs and the SPA. Institutionalize the training of arts teachers in coordination with the NCCA.
2. Appoint two permanent representatives to the NCCA-DepED Cultural Education Program Committee (NDCEPC).
3. Ensure active engagement of the NCCA in the development of appropriate curriculum on Philippine arts and culture, instructional materials, and teachers training.
4. Ensure the integration and efficient implementation of the NDCEP and its inclusion in the DepED annual workplan.
5. Support participation of DepED students, teachers, and administrators in various NCCA programs for cultural enrichment activities such as the Philippine Arts Festival / National Arts Month, National Heritage Month, International Dance Festival, Indigenous Peoples Month, and the Philippine Cultural Education Program (PCEP), among others.
6. Pave the way to ensure the recognition of expertise of the "Masters of Living Tradition (MLT)" to qualify them to teach part time in view of such expertise.
7. Provide counterpart funding for the implementation of the NDCEP.

C. The NCCA-DepED Cultural Education Program Committee (NDCEPC) shall:

1. Convene within fifteen (15) days after the signing of this Memorandum of Agreement.
 2. Conduct regular meetings or may call for special meetings as deemed necessary.
 3. Elect a Chairperson and a Vice-Chair from among themselves, ensuring the representation from both parties among the members of the committee.
 4. Create Ad-Hoc committee(s) to craft the component projects and activities and consolidate them into the NDCEP.
 5. Ensure that the provisions and commitments of both parties stipulated in this Memorandum of Agreement shall be complied with.
 6. Conduct regular assessment and evaluation of the NDCEP and make necessary suggestion/s.
 7. Prepare reports for the information and appreciation of the NCCA national committees and the Board of Commissioners and the Secretary of the Department of Education.

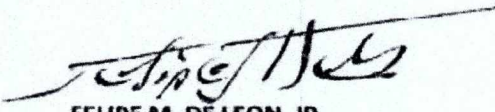
This Memorandum of Agreement shall take effect immediately upon signing by both parties and shall continue to be in force until revoked or superseded.

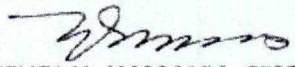

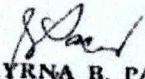

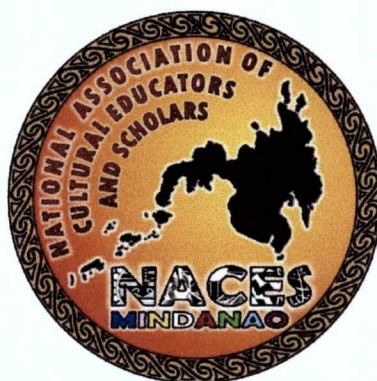

Background & Rationale

Cognizant of the need to accelerate the process of integrating culture in the basic education curriculum and mainstreaming it in the national development plans, the NCCA Board of Commissioners, in its September 2001 meeting, resolved that a Philippine Cultural Education Plan (PCEP) be formulated and operationalized. In 2002, PCEP was launched as a comprehensive Commission flagship program.

With the enactment of the National Cultural Heritage Act of 2009 on March 26, 2010, PCEP established a major gain by its designation as the body, together with the Department of Education, (Rule XI, RA 10066) in charge of the cultural heritage education in the country. CULTURAL EDUCATION, Section 41. *Incorporation of National Cultural Treasures and Important Cultural Properties in the Basic Education System.* PCEP was tasked to “formulate the cultural heritage education programs both for local and overseas Filipinos to be incorporated into the formal, alternative and informal education, with emphasis on the protection, conservation and preservation of cultural heritage property.” Later, this was reinforced by Republic Act No. 11961 An Act Which Strengthened the Conservation and Protection of Philippine Cultural Heritage through Cultural Mapping and Cultural Heritage Education Program.

The PCEP 3.0 plan 2018-2023 defined 7-Goals: (1) To retrieve, consolidate, enrich, preserve, and provide access to existing bodies of knowledge on Philippine culture; (2) To utilize bodies of knowledge in Philippine culture in creating, developing and disseminating contextualized instructional materials, modules, and other learning resources for the cultural education of Filipinos here and abroad; (3) To define and integrate the minimum learning outcomes and cultural competencies in Philippine culture in the formal, non-formal and informal education; (4) To provide comprehensive and continuing education programs on culture for trainers, teachers, artists, cultural workers, civic leaders, and government officials and workers; (5) To underscore the significance and ensure the implementation of the cultural heritage education provisions of the Heritage Law (RA 10066); (6) To advocate and facilitate the enactment of national and local policies or executive actions for cultural education; (7) To establish coordinative and oversight mechanisms, and continue supporting an NCCA-based office for planning, organizing, implementing, coordinating, integrating and monitoring of PCEP initiatives at the local, national and international levels.

PCEP training design covers a panoply of approaches, methodologies, strategies, and contents grounded in the unique cultural beliefs, values, norms, heritage, practices, language, experiences, and cultural expressions of a community. It operates in the three modes of learning: formal, non-formal and informal education. All programs of PCEP contribute to the fulfilment of PCEP Vision of constituting “a nation of critically informed, culturally literate, and empowered Filipinos. Some major outcomes of the program are manifested by the thousands of active teacher-scholars who graduated from GDCE and GDTA nationwide and are alumni members of the National Association of Cultural Educators & Scholars (NACES). In addition, MA, and PhD graduates of Cultural Education, are now actively engaged in their respective communities doing cultural advocacy works. Moreover, innumerable participants have benefitted from a wide array of needs specific culture-based training schedules designed for LGU executives, political leaders, government employees, cultural workers, artists, students, and civil society.

For the next 5-years (2025-30) PCEP intends to further invigorate its programs and projects to bolster its sterling accomplishments. Last year (2023), we have introduced new projects that are aligned with the UNESCO Global Citizenship Education (GCED) and Education for Sustainable Development (ESD) such as the Retooling Workshop of PCEP Faculty on GCED and ESD, and the highly successful KABARO Conference on Gender Awareness and Sensitivity participated in by the country's leading activist-scholars in the area of Women and Gender Studies, BLGBT Studies, and Transnational Queer Studies, with a thousand attendees in zoom and 1,700 in FB closed group live streaming platform. Relatedly, more activities supporting both UNESCO heritage education and sustainable development initiatives are in the offing.

The **Pagsasanay sa Edukasyong Pangkultura (PEP)** is expected to contribute in the achievement of objectives of the Philippine Cultural Education Plan for **2026 -2030**, which include the following:

Objective No. 1: To retrieve, consolidate, and curate existing body of knowledge on Philippine culture in creating, and disseminating learning resources for the cultural education of Filipinos here and in the global elsewhere

Objective No. 2: To formulate and integrate cultural competencies in formal, non-formal, informal, alternative, and special needs culture-based instructions that highlight the pivotal role of culture as impetus for, and driver of sustainable economic growth and cultural development

Objective No. 3: To provide foundational, and continuing culture-based education programs for teachers and students, cultural workers and artists, government officials and employee, indigenous communities and Filipino communities in diaspora, cultural stakeholders and members of civil society, using decolonial and decolonizing frameworks for cultural empowerment and social transformation.

Objective No. 4: To integrate social, cultural, and environmental justice approaches, methodologies and theories in decolonial, culture-based heritage studies that promote education for sustainable development and global citizenship.

Objective No. 5: To internalize and advocate the principles of equity, equality, diversity, and inclusion as culture-based ethical thinking and everyday relational practice of *pakikipagkapwa*

Objective No. 6: To underscore the significance and ensure the implementation of the cultural heritage education provisions of the National Cultural Heritage Act of 2009 (RA 10066) as amended, through the auspices of the Philippine Cultural Education Program of the National Commission for Culture and the Arts.

Objective No. 7: To advocate and facilitate the enactment of national and local policies or executive actions in collaboration with line agencies and PCEP PLAN-users in strengthening the sense of patriotism and nationalism using the archipelagic perspective of Philippine culture-based education.

Objective No. 8: To establish linkage and oversight mechanisms that actively support an NCCA-based PCEP Office in the planning, developing, organizing, coordinating, and implementing of PCEP projects and initiatives at the local, national, and international level

Description

PAGSASANAY SA EDUKASYONG PANGKULTURA or PEP is a prerequisite of NCCA-PCEP to qualify for any of its scholarship programs such as GDCE, GDTA and other Training Certificate courses. PEP is a National Teachers' Training Program on Culture-Based Teaching in the different learning areas. It is a three (3) day orientation, training, and consultation on the different facets of culture-based education, with a maximum of 200-pax participants.

The project is an orientation on Culture-based education discipline discussing a unified culture- based approach to the teaching of the Basic Education Curriculum. Strongly aligned with the program objectives of the NCCA Philippine Cultural Education Plan, the seminar-workshop intends to familiarize teachers regarding the nature, purview, methods, approaches and frameworks of culture-based learning and instruction. In addition, it seeks to promote networking among teachers, scholars, and cultural workers so that we can generate productive experiences, best practices, and models of culture-based education in various learning areas.

Orientation on Culture-based Education, Culture-based Lesson, and PCEP Scholarship and teachers-training-conference on Cultivating Filipino Identity through the Arts, Filipino sa Sining at Desenyo, and Events and Production Management.

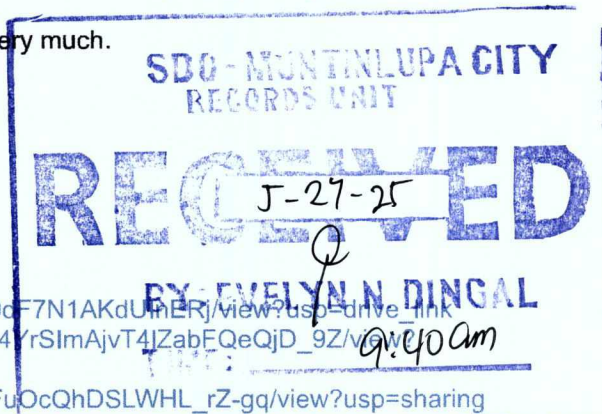
