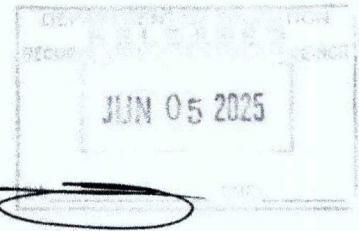

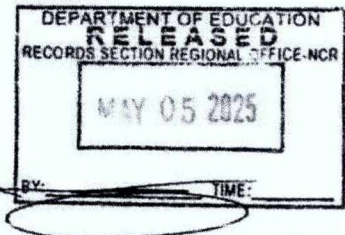

1. Pursuant to DepEd Order 10, s.2025 titled Guidelines for the Implementation of the 2025 Department of Education Summer Programs, dated April 7, 2025, the Department of Education - National Capital Region through the Curriculum and Learning Management Division (CLMD) shall implement the above-captioned program.

5. Refer to the following issuances for the detailed implementing guidelines of each program.

- **SARP:** DM 035, s.2025 Supplemental Guidelines for the Implementation of Summer Academic Remedial Program
- **NLC:** DM 036, s. 2025 Supplemental Guidelines for the Implementation of the 2025 Learning Camp

5. The Tara, Basa! Tutoring Program is implemented in partnership with the Department of Social Welfare and Development (DSWD), which provides tutors to support learners. In view of this, a **shadow teacher** shall be provided for the tutors to supervise and guide them during the program. Below are the terms of reference for shadow teachers:

- He/she must be a seasoned Grade 1 teacher who is willing to serve as a shadow teacher.
- Provide technical assistance to tutors during sessions.
- Ensure that the competencies provided by tutors are aligned with the objectives of the program.
- A shadow teacher shall assist a minimum of 3 to 5 tutors per school.

6. Additionally, a shadow teacher shall be entitled to accumulated service credits based on the number of hours rendered, and meal provision can be outsourced or charged against local funds, subject to the usual accounting and auditing rules and regulations.

7. To ensure effective monitoring during program implementation, the Schools Division Offices (SDOs) shall conduct scheduled validation visits to participating schools, review learner progress data on a weekly basis, and provide immediate support as needed. Similarly, the Regional Office, through the Curriculum and Learning Management Division (CLMD), shall conduct spot checks and technical assistance visits to ensure compliance with program standards. The following are the designated CLMD lead monitors for the said summer program. The Regional Remediation Program (RRP): Regional Initiative for Students' Excellence in Numeracy and Literacy integrates existing remedial efforts across the region to provide targeted support in reading and mathematics. It aims to strengthen learners' foundational skills and competencies, ensuring they are better prepared for continued learning and successful progression to the next grade level.

The RRP will focus on Reading (English) and Mathematics for the following grade levels:

Remediation sessions will be conducted from Monday to Thursday, with two hours allocated for Reading and two hours for Math each day. Fridays will be dedicated to LAC sessions, as well as the preparation of materials and reports.

Learning resources for use during the remediation period can be accessed through this link: <https://tinyurl.com/Regional-Summer-Prag-Materials>. The Schools Division Offices (SDOs) or individual schools, using the downloaded funds, will facilitate the printing and procurement of other necessary materials in accordance with accounting rules and guidelines. However, teachers are encouraged to use additional learning resources, beyond the provided materials, to further support and enrich instruction.

Participation of teachers in the program shall be on a voluntary basis. The School Head is tasked with identifying prospective teachers to handle specific learning areas, particularly Mathematics and English, based on their qualifications and their suitability to meet the requirements of the Summer Programs. Priority will be given to teachers who exhibit willingness, commitment, and high proficiency in their respective subject areas.

To recognize their efforts, teachers shall be provided with various incentives, subject to existing government rules and regulations. These incentives include service credits in accordance with the provisions of DepEd Order No. 13, s. 2024; meal expense; a Certificate of Appreciation for teachers and/or volunteers, and other allowable incentives, depending on the availability of funds and in line with pertinent guidelines.











- 1.0. This memorandum is issued to establish guidelines on the release and utilization of the Program Support Funds (PSF) for the implementation of the following DepEd Summer Learning Programs, namely:
 - 1.1. Bawat Bata Makababasa Program (BBMP);
 - 1.2. Literacy Remediation Program (LRP);
 - 1.3. Summer Academic Remedial Program,
 - 1.4. and 2025 Learning Camp
- 2.0. The total budget amounting to *Php 1,562,466,681.19* of which *Php 1,199,013,750.00* (under the FY 2025 GAA or R.A. No. 12116) and *Php 363,452,931.91* (under the FY 2024 GAA or R.A. No. 11975) will be used for this program. The said funding requirements will be sourced from the National Learning Camp budget allocation from the FY 2025 Current and Continuing Funds of the Basic Education Curriculum (BEC), and other possible sources

subject to the existing budgeting, accounting, auditing, and procurement rules and regulations.

- 3.0. The allotment for the Program Support Fund (PSF), which has been downloaded and directly released to the DepEd Regional Offices, may be further downloaded to the Schools Division Offices (SDOs) or Implementing Unit (IU) – Schools. The PSF fund shall be used for the following, subject to the specific requirements shown in *Annex A*:
 - 3.1. Provision of Teaching-Learning Resources;
 - 3.2. Supplies and Other Materials;
 - 3.3. Travel Expense:
 - 3.3.1. For DepEd personnel
 - 3.3.2. For Program Resource Persons (non-DepEd personnel)
 - 3.4. Meals Expense:
 - 3.4.1. For Learners, teachers, and tutors
 - 3.5. Board and Lodging;
 - 3.6. Honoraria;
 - 3.7. Other program-related in compliance with the provision of the program guidelines, subject to the existing budgeting, accounting, auditing, and procurement rules and regulations.
- 4.0. The ROs, SDOs, or Schools shall facilitate the provision and distribution of learning resources and other supplies and materials based on the present number of participants and teachers per school. The said learning resources, as well as other supplies and materials shall be delivered to the participating DepEd schools. The ROs, SDOs, or schools shall undertake the necessary procurement in the implementation of the program in accordance with the applicable provisions of Republic Act (RA) No. 9184 or the Government Procurement Reform Act and its Implementing Rules and Regulations (IRR) or RA No. 12009 or the New Government Procurement Act and its IRR.
- 5.0. The utilization of the funds herein shall be in accordance with the existing budgeting, accounting, auditing, and procurement rules and regulations.
- 6.0. The budget allocation for the authorized activities under the DepEd Summer Learning Programs is indicative. The Regional Offices are authorized to make necessary adjustments in the allocation for the effective implementation of the Program.
- 7.0. The ROs or SDOs shall ensure the obligation and disbursement of FY 2024, and the FY 2025 program support funds are in accordance with the Cash-Based Budgeting System and consistent with the National Budget Circular No. 595 s. 2025 (Guidelines on the Release of Funds for Fiscal Year 2025 dated January 20, 2025).
- 8.0. The Statement of Expenditures (SOEs) shall be submitted to Office of the Assistant Secretary of Curriculum of Teaching - Bureau of Curriculum Development (BCD), and Bureau of Learning Delivery (BLD) through email: msct@deped.gov.ph copy furnish epmo@deped.gov.ph at the **end of every month** until the said fund has been fully utilized.
- 9.0. The attached are as follows:

 - 9.2. Annex B - Budget Allocation per Learning Program

11.0. Technical Specifications will be provided by the program leads to each Region subsequently.
