1. In line with the implementation of the **Revised K to 10 Curriculum for Grades 2, 3, 5, and 8**, all concerned are hereby informed of the conduct of the **Online Briefer for ALL Grades 2, 3, 5, and 8 Teachers (G2358)**. The briefer for **Grades 2 and 3 teachers will be held on June 9, 2025 (Monday), 8:00 AM onwards**, while the session for **Grades 5 and 8 teachers will be conducted on June 13, 2025 (Friday), 8:00 AM onwards**. Both sessions will be held via Microsoft Teams.
2. The **MS Teams link** for the said activity will be sent to the participants' **official DepEd email accounts** on or before June 8, 2025.
3. The objective of this activity is to provide a clear overview of the revised curriculum for Grades 2 and 3 to guide teachers as they prepare for the opening of classes in June. The briefer will focus on the curriculum framework, key changes, learning area shifts, and general implementation guidelines.
