PARTNERSHIP WITH NESTLÉ PHILIPPINES INC.

1. MEMORANDUM OF UNDERSTANDING

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Understanding ("Memorandum") is made and entered into by and among:

THE DEPARTMENT OF EDUCATION-NATIONAL CAPITAL REGION of the Republic of the Philippines, through its Regional Office at the National Capital Region, with offices at the DepEd-NCR Complex, Misamis St., Bago Bantay, Quezon City represented herein by its Regional Director **JOCELYN D.R. ANDAYA**, hereinafter referred to as "**DepEd-NCR**";

-and-

GREATFIL TEAM, INC., a domestic corporation duly organized and existing under and by virtue of Philippine laws, with office address at 37A Masikap St., Diliman, Quezon City, represented in this Act by its President, **MR. PATRICIO GOC-ONG**, hereinafter referred to "**Greatfil**";

-and-

NESTLÉ PHILIPPINES, INC., a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with administrative offices at the Nestlé Center, 31 Plaza Drive, Rockwell Center, Makati City, represented in this Act by its Senior Vice President and Head of Corporate Affairs, **MR. JOSE T. UY III**, hereinafter referred to as "**NPI**";

RECITALS

WHEREAS, the DepEd-NCR is the lead government agency that formulates, implements, and coordinates policies, plans, programs and projects in the areas of formal and non-formal basic education and supervises all elementary and secondary education institutions under its jurisdiction;

WHEREAS, NPI, through its Corporate Affairs Department, will provide a school-based wellness program entitled the "SY 2025-2026 Nestlé Wellness Campus" (the "Project" or the "Program") which shall be organized and implemented through and with the assistance of Greatfil;

WHEREAS, NPI aims to collaborate with DepEd-NCR to improve the foundational skills of learners and foster learner-centered environments by providing learning resources and organizing inter-school activities while promoting nutrition, health and wellness, ultimately contributing to the development of stronger and healthier students.



WHEREAS, DepEd-NCR, NPI and Greatfil desire to collaborate for the successful implementation of the Project in all DepEd-NCR Junior High Schools, Senior High Schools and Public Elementary Schools located in the National Capital Region from 15 May 2025 to 30 April 2026;

NOW, THEREFORE, the Parties hereby set out the terms and conditions under which this partnership will be governed.

1. NPI, with the assistance of Greatfil, has established and intends to implement the Project, a program that aims to educate public high school and elementary students located in the National Capital Region on nutrition, health and wellness to establish healthier eating, drinking and lifestyle habits. The Project shall be organized and conducted pursuant to the Program mechanics attached hereto as Annex "A".
2. NPI shall have the following obligations:
 - 2.1. NPI will provide learning resources on nutrition, hygiene, physical activity, and solid waste management for public elementary and junior high schools.
 - 2.2. Create, produce, and timely provide the following learning resources required for the Project:
 - a. Educational videos and worksheets on nutrition and physical activity topics, tailored according to key stages
 - b. Modules on hygiene and solid waste management
 - c. Educational videos on nutrition for parents
 - d. Dancercise music
 - 2.3. In collaboration with external experts, develop a validated tool that will help assess the knowledge, attitudes, and behavioral intention of food and nutrition habits among the learners following the implementation of the Project's learning resources.
 - 2.4. Through Greatfil, conduct regional and division cascades of the mechanics and details of the Program to the DepEd-NCR Regional Representatives and Division Supervisors duly assigned to handle the program and cascade the mechanics and implementation plan per division or district to the MAPEH and/or PE School coordinators and principals.
 - 2.5. To provide timely and effective media amplification for the Project on print, TV and digital (web and/or internet-based) media.
 - 2.6. Through Greatfil, invite public school teachers and parents to join the Nestlé Wellness Campus Facebook communities.
 - 2.7. Organize and manage the Inter-school contest and other wellness-related events like webinars, cooking demos and Nestlé-sponsored activities.
 - 2.8. Coordinate with Greatfil and the DepEd-NCR for the orderly implementation of the Project
 - 2.9. Together with Greatfil, conduct meeting alignment and updates pertaining to the Program with DepEd-NCR stakeholders

3. The DepEd-NCR shall have the following obligations:

3.1. Through the DepEd-NCR Regional Director:

- a. Endorse the Project to all Division Superintendents within the region;
- b. Provide guidance and technical advice to ensure proper implementation of the Project
- c. Suggest and recommend on the progress of the Project moving forward based on final results provided that all obligations of the other parties had been fully carried out.

3.2. Through the Education Support Services Division (ESSD) Chief

- a. Coordinate with Greatfil and DepEd-NCR Division Supervisors duly designated for the program implementation
- b. Facilitate the issuance of the endorsement letter to all DepEd-NCR Division Supervisors of and to all Superintendents in the region
- c. Assist Greatfil in monitoring Project execution in the region
- d. Provide recommendations on how to improve the Project moving forward.
- e. Monitor the implementation of the program in the Region
- f. Organize the regional cascade together with Greatfil

3.3. Through the Policy, Planning, and Research Division (PPRD) Chief:

- a. Coordinate with Greatfil and DepEd-NCR Division Supervisors/Senior Education Program Specialists (SEPSs) on the conduct of the research related to Clause 2.2 above and Clause 3.3 (b) below.
- b. Identify the schools to be included in the sampling frame
- c. Facilitate the issuance of an endorsement letter to Division Superintendents, Division Supervisors and School Principals of the schools involved in the research
- d. Provide recommendations based on the provided Project Report drawn from the results of the study

3.4. Through the duly designated DepEd-NCR Division Supervisor:

- a. Coordinate with Greatfil and the PDO IV or ESSD Chief or PPRD Chief in the program implementation
- b. Attend the regional program cascade conducted by Greatfil and ESSD Chief of the region
- c. Receive and facilitate the distribution of different learning resources provided by NPI through Greatfil for his/her division
- d. Assist Greatfil in monitoring the program execution, ensuring that all the schools in his/her division will receive the learning resources
- e. Assist Greatfil and DepEd-NCR Regional Officials during video and photo coverage, and media interviews that will be conducted by NPI representatives or partner agency
- f. Submit all reports and documentation asked by the regional office, thru the PDO IV or the ESSD Chief.

- 3.5. Through the School Principals:
- a. Send links to the electronic consent form to the MAPEH and/or PE School Coordinators to secure the latter's consent to provide their names, email addresses, and mobile numbers to Greatfil for purposes of joining the Project;
 - b. Once the MAPEH and/or PE School Coordinators have responded to the electronic consent form, validate their identities with Greatfil.

- 3.6. Through the MAPEH and /or PE School Coordinator:
- a. Implement the Program in his/her school
 - b. Receive the links to all the learning resources coming from the DepEd-NCR MAPEH Division Supervisors and/or NPI, through Greatfil
 - c. Lead and monitor the use of the Nestlé Wellness Campus modules and dancercise, which may involve adapting or integrating the learning resources to different learning areas and/or learning delivery modes that is most appropriate for them
 - d. Coordinate all concerns pertaining to program implementation with Greatfil and/or the DepEd-NCR Division Supervisor
 - e. Submit all reports and documentation asked by his/her DepEd-NCR MAPEH Division Supervisor

4. Greatfil shall have the following obligations:

- 4.1. Manage and supervise the Project, which shall include:
- a. Cascade of program mechanics and implementation guidelines to DepEd-NCR Regional Director, ESSD Chief, DepEd-NCR MAPEH Division Supervisors assigned to the program, Principals and MAPEH school coordinators
 - b. Securing permits and endorsements from DepEd-NCR Regional Office to implement the Program to the schools
 - c. Organize meeting alignment and updates pertaining to the Program with NPI and DepEd-NCR stakeholders
 - d. Lead in monitoring the implementation of the Program
 - e. Organize and manage Facebook Messenger groups in each division or district to answer queries pertaining to the Program, contest mechanics and distribution of prizes which shall include regional office PPRD Chief and ESSD Chief, for them to have a good grasp of all matters related to the Project
 - f. Invite teachers and supervisors to join the Nestlé Wellness Campus Facebook Group
 - g. Manage photo and video documentation and facilitate media interviews based on the direction of NPI and budget allocation
 - h. Coordinate for the conduct of research in the selected areas and schools conducted by NPI's research partner
- 4.2. Handle logistics for the Project, which shall include:
- a. Distribution of Nestlé Wellness Campus modules, dancercise music, and parent modules to the DepEd-NCR MAPEH Division Supervisors, MAPEH and/or PE School Coordinators
 - b. Delivery of prizes, tokens and certificates to schools, region and division offices
 - c. Installation of Nestlé Wellness Campus streamers in selected schools

d. Collection of basic personal information of DepEd-NCR MAPEH Division Supervisors and teachers, which is limited to their name, mobile number, email address. This will allow Greatfil to have a timely communication with DepEd-NCR stakeholders, NPI to validate the teachers' identity in the Nestlé Wellness Campus Facebook Group, and to facilitate the delivery of certificates, prizes or tokens

- 4.3 Responsible for the proper and timely execution of the following:
- Nestlé Wellness Campus program implementation
 - Program cascade
 - Distribution of learning resources, tokens, prizes and other giveaways
 - Submission of monitoring and post evaluation reports

5. The Parties understand and agree that:

- 5.1. Their representatives to this Memorandum are duly authorized to sign the same and to bind the organizations to the terms and conditions thereof.
- 5.2. For any and all articles, endorsements, press releases and communication materials in connection with the Project or the Parties' involvement in the Project, NPI and DepEd-NCR must be duly acknowledged. Moreover, no such article, endorsement, press release or communication material shall be made without the prior approval of both NPI and DepEd-NCR.
- 5.3. All rights to the Nestlé Wellness Campus modules and wellness dance/cercise music specified in Clause 2 of this Memorandum belong to NPI. The wellness song, modules, or any portion thereof, can be copied, reproduced, transmitted, uploaded or otherwise used only with the express written consent of NPI, or if the same were already distributed to the public schools.
- 5.4. NPI and Greatfil shall be allowed to record any portion of the Project and to use the same in communications material of NPI for television, print and/or internet/web-based media provided that consent of the individual/s that will be involved were sought.
- 5.5. The Project shall not be entered into any competition, contest, recognition ceremony, publication or other similar event and publications without the prior consent of both NPI and DepEd-NCR. At such events, the Parties shall ensure that both NPI and DepEd-NCR are properly acknowledged.
- 5.6. The Parties shall not use each other's logos and/or trademarks on any press releases or communication materials without each other's written approval.
- 5.7. The Parties manifest their support of the international and national efforts to promote quality nutrition for children and all Parties adhere to and strongly support in principle and practice the provisions of Executive Order No. 51 or "The National Code of Marketing of Breast Milk Substitutes, Breast Milk Supplements and Related Products" and its Revised Implementing Rules and Regulations. Any violation of the Revised Milk Code and/or Revised Implementing Rules and Regulations shall be deemed a breach

of this Memorandum and shall constitute grounds for the immediate termination of this Memorandum without need of further notice.

5.8. Any use of personal information and/or sensitive personal information by the Parties shall accordingly be protected and treated with confidentiality and privacy, during and even after the termination of this Memorandum, consistent with RA 10173, otherwise known as the Data Privacy Act of 2012, its IRR and other relevant laws, rules, and regulations.

6. After the duration of the Project, as specified in Annex "A" of this Memorandum, the rights of the parties over the output of the Project shall be as follows:

6.1. This Memorandum does not grant either party any rights or license to the other party's intellectual property.

6.2. Contest submissions and photo video documentation of the Project shall jointly belong to the DepEd-NCR and NPI. It is the responsibility of DepEd-NCR, through the schools, to obtain consent of the parents/guardians of the participating students in relation to the photo/video documentation of the event. It is the responsibility of DepEd-NCR, through the schools, to obtain the consent of the parents/guardians of the participating students in relation to the photo/video documentation of the event. Either party shall be free to use the same in-connection with the Project without prior permission from the other. Where use shall be purposes outside of the Project, the other party's prior consent shall be obtained in writing.

6.3. The copyright over the research specified in Clause 2.6 hereof shall belong to NPI. DepEd-NCR may make use of these materials, provided prior consent is given by NPI, which shall not be unreasonably withheld, and the copyright of NPI is acknowledged on the materials of DepEd-NCR. DepEd-NCR will be provided with a copy of the materials and may use the same for policy formulation with acknowledgment on NPI.

7. NPI and DepEd-NCR shall hold each other free and harmless from any and all claims made or filed by any person arising from any loss, damage, injury, or fault or misconduct committed during or on occasion of implementation of the Project.

8. The Parties hereby acknowledge that, in the course of carrying out their obligations and duties in connection with the Project, they, their employees, agents or representatives, may receive from, or be furnished by or on behalf of, the Project Implementers information of a confidential nature (the "Confidential Information"). The Parties acknowledge an obligation to limit their disclosure of Confidential Information to those persons with a legitimate need to know and only under conditions of confidentiality. The Parties further agree not to exploit the Confidential Information except to use the same for purposes contemplated under this Memorandum.

The obligations of confidentiality and restricted use shall not apply to Confidential Information which:

8.1. is already in the public domain or within public knowledge prior to the execution of this Memorandum;

8.2. is required to be disclosed under any applicable law or regulation or any judicial order, provided that, in such event, the receiving party shall:

- a. give the disclosing party immediate written notice thereof (including the manner of disclosure required) as soon as reasonably practicable, together with a written legal opinion confirming the required disclosure, unless such notice is prohibited under such law, regulation or judicial order; and
- b. not affect any disclosure that is more extensive than that required by such law, regulation or judicial order and take all reasonable actions to seek confidential treatment of the Confidential Information disclosed.

9. This Memorandum is entered into on a fair and arms-length basis. Each party warrants that it has not given any gift, consideration, commission, reward, grant or endowment, to any officer, employee or representative of the other parties in connection with the negotiation, signing or implementation of this Memorandum; nor has entertained any solicitation for any such gift, consideration, commission, reward, grant or endowment in connection with the negotiation, signing or implementation of this Memorandum.

10. After this Memorandum terminates or expires, the terms and conditions that expressly or by their nature contemplate performance or observance after the termination or expiration of this Memorandum shall survive and continue in full force and effect until completely performed or observed.

11. This Memorandum is the whole agreement between the parties hereunder. No amendment of any of the foregoing terms and conditions shall be considered as having been made unless executed in writing and duly signed by the parties.

12. Should any provision or portion of this Memorandum be declared illegal or void by any future legislation or duly constituted authority, the other provisions or portions not so declared shall remain in full force and effect, without either party becoming liable to the other therefore.


13. This Memorandum shall commence from the execution and shall be valid and effective until 30 April 2026. DepEd-NCR and NPI may terminate this Memorandum at any time with thirty (30) days prior written notice to other parties.

14. This Memorandum shall be governed by the laws of the Republic of the Philippines. In the event of any issue or dispute arising out of or in connection with this Memorandum, the parties shall, in all cases, endeavor to settle the issue or dispute amicably. Nothing herein however, shall prevent the parties from submitting any issue or dispute to preventive mediation or arbitration as the case may be. In case of failure to reach an amicable settlement between the parties, as herein provided, either of the parties may resort to appropriate judicial action/s which shall be brought before the proper courts of Makati City, Metro Manila, to the exclusion of all other courts.

MECHANICS:

The DepEd and Nestlé Wellness Campus Program (the "Program") is a partnership between the Department of Education (DepEd) and Nestlé Philippines, Inc. (NPI) and will be implemented by Greatfil Team, Inc. (Greatfil).

The Program will be implemented through the participating DepEd Regional Offices who will appoint the Division Supervisors or other DepEd officials to ensure that the Program will be implemented in all schools in their respective divisions in both elementary and junior high school levels. Division

Supervisors or those appointed by the DepEd Regional Office in coordination with the Division Office will also be the contact persons in their respective divisions.

The S.Y. 2025-2026 Program Implementation will give more emphasis on developing the students, teachers, and parents' healthier habits through nutrition education, physical activity, and solid waste management. The Nestlé Wellness Campus Facebook Communities will serve as a platform for inter-school competitions, a repository of modules, music, and videos, and a space for parents and teachers to share wellness ideas and practices. Additionally, webinars, cooking demos, and Nestlé-sponsored activities will be conducted on these digital platforms.

The implementation of the Program will be in three (3) parts, as follows:

Part 1: NUTRITION EDUCATION FOR ELEMENTARY, JUNIOR HIGH SCHOOL STUDENTS AND ADULTS (Teachers and Parents) IN ALL PUBLIC SCHOOLS IN THE NINE (9) PARTICIPATING REGIONS.

1. NPI, in collaboration with Greatfil, will provide modules in the form of video content. These videos are encouraged to be integrated into the Elementary and Junior High School MAPEH curriculum, in accordance with DepEd rules and regulations.
2. Video modules will also be made available for parents, which can be utilized during PTA meetings or other face to face sessions in school. These modules aim to educate parents about the significance of good nutrition, maintaining a balanced diet, and understanding food labels.
3. Worksheets and activities are provided for students and/or parents to read and work on together, either at home or in the classrooms whenever feasible.
4. To ensure smooth program implementation, NPI, through Greatfil, will provide soft copies of the following materials to both division supervisors and MAPEH school coordinators:
 1. Lesson guides
 2. Videos of the modules
 3. Worksheets
 4. Contest Mechanics
5. For faster distribution, they may also get a copy of the materials through the Greatfil representatives.

Part 2: NESTLÉ WELLNESS CAMPUS DANCERCISE

1. NPI, through Greatfil, will provide a soft copy of the official Nestlé Wellness Campus dancercise

music and choreography video to each Division Supervisor in charge of the Program.

2. Teachers are encouraged to use the dancercise as a warm-up exercise during the flag ceremonies, during PE classes, and other related activities.

Part 3: SY 2025-2026 NESTLÉ WELLNESS CAMPUS CONTESTS AND RECOGNITION

The current school year marks the 13th year of the Nestlé Wellness Campus program. NPI, through Greatfil, aims to make the program more fun and exciting through different competitions, allowing students, teachers, and parents to apply the knowledge gained from the provided modules. Winners who excel in these competitions will receive well-deserved recognition, while also contributing scores that will contribute to their respective regions' success.

The competitions will have three (3) categories, namely:

- A. Inter-school Competition
- B. Inter-division Competition
- C. Inter-region Competition

A. INTER-SCHOOL COMPETITION

1. The inter-school category is open only to all public schools in both elementary and junior high school in the nine (9) participating regions namely:

- i. National Capital Region (NCR)
- ii. Region 4-A – CALABARZON
- iii. Region 5 – Bicol Region
- iv. Region 6 – Western Visayas
- v. Negros Island Region (NIR)
- vi. Region 7 – Central Visayas
- vii. Region 8 – Eastern Visayas
- viii. Region 10 – Northern Mindanao
- ix. Region 11 – Davao Region

2. Schools are strongly encouraged to participate in all categories. Interested schools must submit the registration form and ensure that students have duly signed the consent waiver form to confirm their participation.

3. The inter-school competitions are as follows:

- i. Nestlé Wellness Campus Hataw Sayaw Year 3
- ii. Nestlé Wellness Best Implementing School
- iii. Sarap Sustansya Cook Off Competition (Junior High School only)

4. Kindly refer to the attached sheets for the mechanics for each competition.
5. Each school is permitted to submit only one (1) entry for each competition. However, integrated schools have the opportunity to submit two entries: one (1) for the elementary level and one (1) for the junior high school level. The Sarap Sustansya Cook-off, on the other hand, is exclusively for the Junior High School level.

B. INTER-SCHOOLS DIVISION COMPETITION

The school year 2025-2026 marks the third year of the NWC Program's Implementation of the inter-division competition, aimed at recognizing the Schools Division that demonstrates excellence in program implementation.

Inter-Schools Division Competitions are as follows:

1. *Outstanding Schools Division of the Year*
2. *NWC Dance Masters for Teachers (refer mechanics in a separate sheet)*
3. *Outstanding NWC Focal Person of the Year*

The Inter-Schools Division Category will have two levels as follows:

- o Regional level
- o National level

In the regional level competition, the winner will be determined based on NWCP implementation in all schools in the division and the performance of the schools representing the division in the regional level competitions. The winning division will be declared the Outstanding Schools Division of the Year in the region and correspondingly the focal person assigned will be declared the "Outstanding Focal Person of the year" in the region.

In the national level competition, the Top Three (3) Schools Divisions will be determined based on the following:

1. Overall Program Implementation of the Nestlé Wellness Campus in their respective division;
2. Performance of the Schools Representing their Division/Region in the national-level competitions;
3. Participation and Performance in the NWC Dance Masters for Teachers, where teacher-representatives from the division competed in the on-line platform at the national level.

The combined scores from these components will determine the final ranking.

The Top Three Schools Divisions will be awarded the title:

- NWC Most Outstanding Schools Division of the Year – Nationwide
- First Runner-Up
- Second Runner-Up

In addition, the **Division Focal Persons** who led these top three divisions will be recognized as follows:

- National Outstanding Division Focal Person of the Year-Nationwide
- First Runner-Up
- Second Runner-Up

The NWC Inter-region competition for the Best Region of the Year is divided into two parts and will have the corresponding weights as follows:

Note: Assigned DepEd Division Supervisors will ensure that those who will participate in the Program are legitimately enrolled grades 1-6 and grades 7-10 students.

In order for a region to achieve the maximum score per criteria, 100% of the schools in the region based on the list validated by the Division Supervisor in charge of the Program should be able to:





1. Implement the video modules for students and parents.
2. Implement the dancercise, whenever possible
3. Submit the duly signed certificates of completion.

Wellness Ambassadors from Greatfil, together with the duly assigned DepEd Division Supervisors will monitor the schools in their respective divisions to validate the school implementation, via actual visit or online, whichever is possible.

Validation period will be announced separately.

**Part 2: (50%) OVERALL SCORE EARNED BY SCHOOLS AND DIVISIONS
REPRESENTING THE REGION IN THE NATIONAL LEVEL COMPETITION**

The overall score of the schools (Elementary and Junior High School) and Schools Divisions representing each region in the National Level competitions will be based on rankings, with points awarded only to entries that place within the Top 20 in each category. The following competitions will be used in the scoring, with their corresponding percentage weights:

1. NWC Hataw Sayaw Year 3 -Video	20%
2. NWC Hataw Sayaw People's Choice	20%
3. NWC Dance Masters - On-line	10%
4. Sarap Sustansya Cook Off	10%
5. Sarap Sustansya People's Chocie	5%
6. NWC Best Implementing School	30%
7. NWC Best Schools Division of the Year	5%

Average scores from Part 1 and Part 2 will be calculated. The region with the highest score will be declared as the "SY 2025-20256 Nestlé Wellness Campus Best Region of the Year" and will receive items of their choice based on the list of items below.
