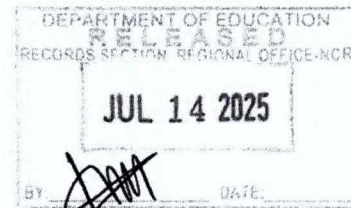

THE DEPED NCR LEARNING RESOURCE PORTAL

1. In line with the Department of Education – National Capital Region’s (DepEd-NCR) commitment to ensure the availability, accessibility, and effective utilization of quality-assured teaching and learning resources, the Regional Learning Resource Portal has been launched to serve as the official repository of curated learning resources from the Central Office, Regional Office, and Schools Division Offices.

2. The Portal can be accessed using the link <https://portal.depedncrlrms.com/>. Specifically, it is designed to:

- a. Provide centralized access to quality-assured teaching and learning resources across subject areas and grade levels;
- b. Facilitate the sharing and dissemination of regionally-developed and division-approved supplementary learning resources;
- c. Enable feedback and evaluation of resources through a structured user interface;
- d. Promote equity and inclusivity by ensuring all learners and teachers in NCR have access to appropriate learning materials; and
- e. Ensure learning continues during on-site class suspension.

3. Relative to its adoption, specific instructions on how to register, log-in, access, utilize, and provide feedback may be accessed using the link <https://tinyurl.com/NCR-USER-GUIDE-LRPORTAL>.

4. To ensure the effective implementation of this initiative, Schools Division Offices (SDOs), through the Curriculum Implementation Division (CID), Learning Resource Management Section (LRMS), and Information and Communications Technology (ICT) Units, are directed to facilitate the registration of all teachers and learners to the Portal. Further, local orientation sessions on the use of the platform shall also be conducted at the division and school levels.

5. A second batch of orientation for key SDO officials and personnel on its utilization shall be conducted on **July 24, 2025, 1:00 – 4:00 PM** at Usec. Varela Hall, DepEd NCR.
