**ANNUAL PSYCHOSOCIAL AND UNIVERSAL MENTAL HEALTH SCREENING**

1. Pursuant to DepEd Order No. 12, s. 2025, titled "Multi-Year Implementing Guidelines on the School Calendar and Activities", and DepEd Memorandum No. 50, s. 2025 or the Learners' Health Assessment and Screening for School Year 2025- 2026, all schools are mandated to ensure access to quality medical, dental, nursing, nutrition, and mental health services that will allow them to their full educational potential. This includes the implementation of comprehensive School Mental Health Programs.
2. To further intensify the program, the division rolled out the **Project C.A.R.E. (Compassion, Access, Response, and Empowerment)**, which focuses on fostering compassion for learners, teaching, and non-teaching personnel's mental health by providing access and response team to empower mental health and well- being in schools.
3. Relative to this, all schools shall begin their **Annual Psychosocial Screening or Rapid HEEADSSS** (G4 to G12 learners) and **Universal Mental Health Screening or Children and Adolescents Risk Screener**, on August 11, 2025 (eight weeks after the start of classes). These screenings may be administered by the School Guidance Designate/Advocate, Homeroom Advisers and Mental Health Focal Person.
4. All schools are enjoined to use the templates, forms and other tools available at <https://tinyurl.com/bdzymdr2>. Submission of Data on Mental Health and Psychosocial Screening is due on or before November 28, 2025, attention to Dr. Maricel R. Subida, Dentist II/ Division Mental Health Focal Person.
