As part of pre-activity, we will distribute YAKAP registration form (PKRF), Consent Form and Guide on how to accomplish the registration form to be distributed to the learners and collected prior to the scheduled activity.

#### Details of Activity

There will be a conduct IEC to inform, educate and register members and their dependents on their preferred YAKAP Clinic (Primary Care Provider) that will be then provide immediate Primary Care Consultation: health profiling and consultation (First patient encounter) in one venue.

3. Distribute marketing collaterals
