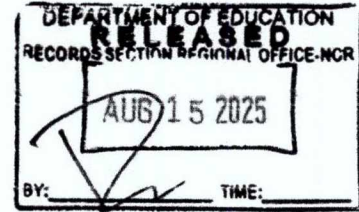

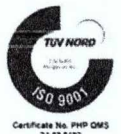
**CALL FOR THE SUBMISSION OF NOMINATIONS FOR THE 2025 DEPED NCR

1. Anchored on the Civil Service Commission Program on Awards and Incentives for Service Excellence (PRAISE) and DepEd Order No. 78 s. 2007, known as Strengthening the PRAISE of Department of Education, all concerned are hereby informed on the above-captioned subject which will commence this **August 12 to September 3, 2025.**
2. Employees from the Regional Office (RO) and Schools Division Offices (SDOs) are eligible to nominate individuals or groups from their own office or other functional divisions, units, or sections at the same governance level for any of the award categories.
