Pursuant to **Administrative Order No. 35, s. 2025**, creating the Inter-Agency Task Force for the hosting of the inaugural **FIFA Futsal Women's World Cup 2025™ (FFWWC25)**, and in support of the request of the **Philippine Football Federation (PFF)** and the **Philippine Sports Commission (PSC)**, the Department of Education (DepEd), through the Operations Strand, enjoins all concerned offices, regional and schools division offices, and public schools to extend full cooperation in the implementation of the following initiatives:

A. Volunteer Program Participation

- All Regional and Schools Division Offices are encouraged to **invite qualified applicants** (teachers, staff, or other personnel) from public schools nationwide to apply for the Volunteer Program for the FFWWC25.

- Schools are encouraged to **integrate attendance at the FFWWC25 games as part of the Physical Education (PE) classes** to promote the sport of futsal and global sportsmanship.
- Tickets for the games will be provided free of charge by the organizers. Further details on ticket distribution will be coordinated with the PSC and PFF.

All concerned offices are hereby directed to coordinate closely with the **Office of the Undersecretary for Operations** and the **Palarong Pambansa Secretariat** for the effective implementation of this directive.

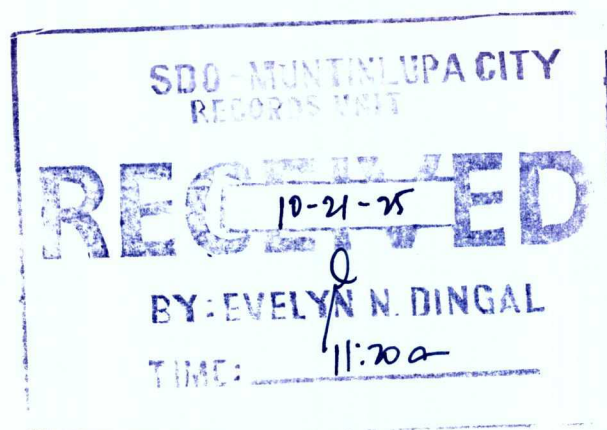
