RESOLUTION TO AWARD

WHEREAS, SDO-Muntinlupa procured *Printing of Test Materials for the Administration of Dynamic Learning Program Assessment (DLAP) (Negotiated Procurement)* with an Approved Budget for the Contract (ABC) of *One Hundred Ninety Seven Thousand Two Hundred Eighty Pesos (P 197,280.00)*;

WHEREAS, the BAC resolved that the procurement mode appropriate for the ABC threshold is Negotiated Procurement - Small Value Procurement (SVP), and recommended the same to the HOPE;

WHEREAS, on September 16, 2025, the BAC Secretariat posted the project in the PhilGEPS;

WHEREAS, on September 19, 2025, one (1) quotation were received, Charkiel Enterprises was disqualified due to non-submission of one Certified True Copy (by the Supplier) of Notarized Omnibus Sworn Statement;

WHEREAS, on September 23, 2025, the BAC Secretariat posted for the second time the project in the PhilGEPS;

WHEREAS, on September 26, 2025, one (1) quotation were received from Grandsmart Enterprise. Was disqualified following post-qualification conducted on October 1, 2025, due to the company is no longer located at the address stated in the Business Permit, PhilGEPS Certification and Omnibus Sworn Statement. There has been no communication or documentation indicating that the company has changed its address;

WHEREAS, on October 03, 2025, the BAC Secretariat posted for the third time the project in the PhilGEPS;

WHEREAS, on October 06, 2025, the BAC Secretariat did not receive any RFQ/sealed envelope;

WHEREAS, all premises considered, the Bids and Awards Committee, resolves as it is hereby resolved to declare the Failure of Request for Price Quotation for the *Printing of Test Materials for the Administration of Dynamic Learning Program Assessment (DLAP)* and recommended to the Head of the Procuring Entity (HoPE) approval to proceed with the Negotiated Procurement;


