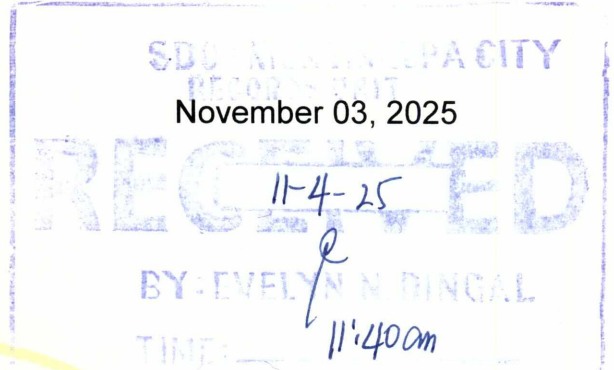

The undersigned would like to respectfully inform your good office that the **Commission on Elections (COMELEC)** have a continuing registration of voters for the November 2, 2026 Barangay and Sangguniang Kabataan Elections (BSKEs). The registration period to file applications are from October 20, 2025 to May 18, 2026, Mondays to Saturdays (including holidays except when declared otherwise by the Commission). The following application types are as follows:

1. Registration
2. Correction of Entries/Change of Name
3. Reactivation (For voters with deactivated records)
4. Transfer of registration records
 - a. From other cities/municipalities
 - b. From within Muntinlupa City
 - c. From Post to Local
5. Updating of Records (for Accessible Precincts)
 - a. Senior Citizen (SC)
 - b. Persons with disabilities (PWD)

In this connection, may we respectfully request to seek your assistance to inform the teachers to update their records in Comelec, Muntinlupa City.
