CONDUCT OF DIVISION ORIENTATION ON THE UPDATED GUIDELINES OF THE NATIONAL FESTIVAL OF TALENTS

1. In line with the implementation of the K to 12 Curriculum and the Department's efforts to provide learners with opportunities to showcase their skills, creativity, and talents in various learning areas, Schools Division Office of Muntinlupa, through the Curriculum Implementation Division (CID), shall conduct a **Division Orientation on the Updated Guidelines of the National Festival of Talents** on **January 7, 2026, 9:00 am to 12:00 pm** at Tunasan National High School.
2. This activity aims to:
 - a. ensure that school heads, teachers, coaches, and focal persons are fully informed of the revised, updated, and harmonized guidelines for the conduct of the National Festival of Talents.
 - b. clarify roles, responsibilities, documentary requirements, and protocols in preparation for the Division, Regional, and National levels of the Festival of Talents.
 - c. provide a platform for addressing issues, concerns, and clarifications regarding the updated categories, mechanics, criteria for judging, and submission of outputs
3. Participants in this activity are Education Program Supervisors, School Festival of Talents Coordinators, and winning trainers/coaches of the Division Festival of Talents per category.
4. This activity shall include presentations on the Overview of the updated NFOT guidelines, revised rules, categories, and mechanics per specialization, and an open forum.
5. Expenses relative to the conduct of this orientation shall be charged to Program Support Funds/Local Funds/Division MOOE or other available sources, subject to existing accounting and auditing rules and regulations.
6. School heads are enjoined to ensure the attendance of trainers/coaches and concerned personnel to guarantee proper dissemination of NFOT updates and smooth preparation for the upcoming festivals.


