

**REGIONAL MEMORANDUM**

**DEPED NCR REGIONAL ATHLETIC ASSOCIATION (DEPED NCR RAA)  
2026 PALARONG PAMBANSA DELEGATION**

1. The Department of Education (DepEd), in collaboration with the Department of the Interior and Local Government (DILG) and the Philippine Sports Commission (PSC), shall conduct the 2026 Palarong Pambansa from May 4-8, 2026 at Agusan del Sur.
2. The Region's participation in the Palarong Pambansa necessitates the concerted effort and support of all sectors of the school system, including the Local Government Units (LGUs), parents, and the community, to ensure the successful participation of the NCR Delegation.
3. Schools Divisions are hereby requested to extend full support to their respective athletes and coaching staff during the training period and their actual participation in the 2026 Palarong Pambansa, which is expected to significantly contribute to the performance of NCR athletes in the national competition.
4. To ensure an orderly system, the Schools Division Office (SDO) Taguig-Pateros, as the designated Host Division of the 2026 Palarong Pambansa, shall take charge of the provision of meals and other related incidental expenses of the NCR Delegation. All SDOs shall be responsible for transporting their respective athletes and coaching staff to and from their respective Division Offices, while the Regional Office shall take charge of other logistical requirements. All Palaro expenses shall be charged against the Special Education Fund pursuant to Section 272 of the Local Government Code, Item 4.1.6.1 Sports Development, of the Joint Circular No. 1, s. 2017.
5. Teacher-coaches, assistant coaches, and chaperons shall be granted service credits, while non-teaching personnel shall be granted Compensatory Time-Off (CTO) not exceeding five (5) days, subject to existing DepEd and Civil Service Commission (CSC) policies and guidelines.
6. The final list of athletes for measurable sports shall be issued under a separate memorandum. Enclosed are pertinent documents for reference.
