

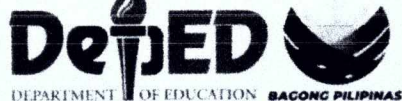
2. In relation to this, the Division organizes the 2026 Private School Summit. The points of discussion during this important engagement are as follows:


