The invitation is open to primary school pupils in Slovenia and abroad. The contest is divided into the following age groups:


- First Group: Pupils from six to eight years old;

- **Drawing’s title,**
- **Mentor’s name and surname,**
- **Mentor’s e-mail address,**
- **And your school’s address.**

A three-member board of experts will carefully examine all drawings. The main criteria regarding the drawings’ evaluation will be children’s creativity.

The best three drawings in each individual category will be given a prize and two recognition awards will be presented for every category.


