1. Pursuant to Regional Memorandum No. 456, s. 2026 titled "*Conduct of the Regional Poster-Making Contest for the 2026 Nutrition Month Celebration*", this Office announces the Division Selection for the 2026 Regional Poster-Making Contest for Nutrition Month.
2. The contest is strictly open to all currently enrolled public Junior High School (JHS) learners across the division. The first-place winner of the Division Level will officially represent the Schools Division Office (SDO) of Muntinlupa City in the upcoming regional competition.
3. Each school must submit its official entries to the Schools Division Office (SDO) on or before **July 02, 2026, at 5:00 PM**. Submissions must include:
 - Physical Entry: The actual hard copy of the poster delivered to the SDO (SGOD-Health and Nutrition Unit).
 - Video Proof: A time-lapsed video of the poster-making process in landscape format, uploaded to the official link: <https://tinyurl.com/5t4p4az9>.
4. The poster must be created on a standard illustration board (15" x 20"), and craypas or oil pastels shall be the only medium used for the artwork. Furthermore, the official Nutrition Month theme, "Nutrisyon at Kalikasan, Ating Pangalagaan," must be clearly reflected in the artwork's overall concept and message.

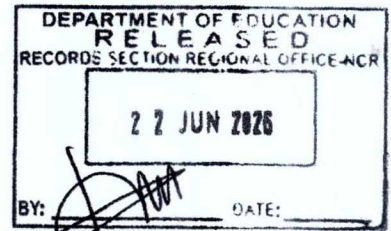

**CONDUCT OF THE REGIONAL POSTER-MAKING CONTEST FOR THE
 2026 NUTRITION MONTH CELEBRATION**

1. This is in reference to the attached letter from the National Nutrition Council at the National Capital Region (NNC-NCR), dated June 15, 2026, relative to the abovementioned subject, contents of which are self-explanatory, for information and appropriate action.
2. All Schools Division Offices (SDOs) are hereby enjoined to conduct their respective Division-Level Poster Making Contests in accordance with the contest guidelines and requirements issued by the NNC-NCR (Enclosure No. 1).

Once confirmed, the entry of the endorsed Division representative shall be submitted for regional evaluation and judging on or before July 15, 2026.
