Resolution to Award No. 2026-001

July 15, 2026

WHEREAS, the Department of Education (DepEd) – Schools Division Office-Muntinlupa City through the ***FY 2026 General Appropriations Act - Republic Act No. 12314 – School-Based Feeding Program with Sub-Allotment Release Order (Sub-ARO) No. RO-NCR-26-00256***, is in need of a supplier for the ***Procurement of School-Based Feeding Program (95 Feeding Days) SY 2026-2027/Project No. 2026 - 001*** with an Approved Budget for the Contract (ABC) in the amount of ***Thirty Four Million Eight Hundred Eight Thousand Nine Hundred Thirty Seven Pesos (P 34,808,937.00)***.

Copy of the Sub-Allotment Release Order (Sub-ARO) No. RO-NCR-26-00256, dated April 13, 2026 under the Program/Project Description School - Based Feeding Program (SBFP) is attached and marked as Annexes "A";

WHEREAS, the HOPE ordered the Bids and Awards Committee to procure this project through a memorandum dated June 03, 2026. Copy of the approved memorandum is attached and marked as Annex "B";

WHEREAS, on June 05, 2026, June 10, 2026 and June 11, 2026, the BAC conducted the Pre-Procurement on the aforementioned project. Minutes of the meeting is attached and marked as Annex "C";

WHEREAS, invitations were prepared on June 24, 2026 and sent to the Commission on Audit (COA), Philippine Chamber of Commerce, Non – Governmental Organization (NGO) – Girl Scouts of the Philippines – Rizal Council, BSP - Muntinlupa City Associate Council, and to School Head/Principal to attend the opening of bids, and which are attached and marked as Annexes "D", "E", "F", "G", "H", and "I";

WHEREAS, the BAC Secretariat posted an Invitation to Bid (ITB) in DepEd Muntinlupa Website, Bulletin Board and at the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 13063071 last June 17, 2026. Copies of the ITB's are attached and marked as Annexes "J", and "K";

WHEREAS, on June 25, 2026, the BAC conducted the Pre-bid Conference. Minutes of the meeting is attached and marked as Annex "L";

WHEREAS, on the deadline of the submission and opening of bids on July 07, 2026; 10:00 am at the Student Center for Life Skills (SCLS), Conference Room (4th Floor), two (2) bidders submitted their bids. Copies of the Minutes of the Bid Opening, Bid Evaluation Report, Abstract of Bids as Read, Checklists for Bid Opening, Bidder's Bid and the Letter of Intent are attached and marked as Annexes "M", "N", "O", "P", "Q", and "R, respectively;

WHEREAS, on July 13 – 14, 2026, the BAC – TWG, conducted post-qualification inspection of Bidders with the lowest calculated bid. Post-Qualification Inspection Reports are attached and marked as Annexes "S series". Recommendation of the BAC-TWG was submitted to the BAC on July 15, 2026, and received by the BAC Secretariat on July 15, 2026, marked as Annex "T".

WHEREAS, on July 15, 2026, the BAC convened and discussed the results of the post-qualification. The BAC declared the bid of **SHMIC General Merchandise (for Lot 1 – Nutri Food Packs)** as the lowest calculated and responsive bidder. Copy of the Minutes of BAC Meeting is attached and marked as Annex "U".

WHEREAS, Section 63.4, Implementing Rules and Regulations of Republic Act Number 12009 (1st Edition), stated to wit: "If the BAC determines that the bidder with the LCB, MEAB, MAB, or HRB passes all the criteria for post-qualification, it shall declare the said bid as the LCRB, MEARB, or MARB, in the case of Goods and Infrastructure Projects, or the HRRB, in the case of Consulting Services, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower...",

WHEREFORE, all premises considered, the Committee resolves, as it is hereby resolved, to recommend to the Schools Division Superintendent as Head of the Procuring Entity (HOPE) the award of Contract for the ***Procurement of School-Based Feeding Program (95 Feeding Days) SY 2026-2027/Lot 1 – Nutri Food Packs/Project No. 2026 - 001*** amounting to ***Twenty Three Million Six Hundred Forty One Thousand Seven Hundred Fifty Nine Pesos and Fifty Centavos (P 23,641,759.50)***.

NOW WHEREFORE, copy of this Resolution to Award (RTA) shall be submitted to the HOPE for approval and the issuance of Notice to Award.

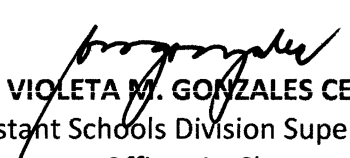
