Greetings!

In the Philippines, there have been alarming cases of **Nihilistic Violent Extremism (NVE)**, where many students have been harmed and in some instances, lives have been lost. These recent incidents are concerning, especially as many of these cases occur within school settings.

In line with this, **SAGIP ng Muntinlupa** based on the initial agreement we had from our consultation dialogue transpired on June 24, 2026, may we respectfully requests the opportunity to conduct an orientation on Nihilistic Violent Extremism (NVE) for teachers. The orientation will be facilitated by either **Ms. Maria Elena Quinagon** or **Ms. Adelfa R. De Guzman**. It will be a two-hour session divided into three parts:

- i. Understanding the meaning and nature of Nihilistic Violent Extremism (NVE)
- ii. Discussing NVE-related cases in Muntinlupa City
- iii. Developing Action Plans to ensure the safety and protection of students

This activity aims to provide teachers with a deeper understanding of NVE, equip them to identify possible warning signs or red flags among students who may be at risk of extremist behaviors, and strengthen the partnership between schools and SAGIP in promoting safe and secure learning environments.
